Effective May 22, CodeRED Weather Warning will cease to be operational in Delaware County. CodeRED Weather Warning alerts those signed up to receive severe weather alerts.

CodeRED Community Notifications will remain in effect for those who have signed-up to receive them.

Community notifications allow registered persons, businesses and commercially available landline numbers to be notified by Delaware County public safety agencies in the event of emergency situations. Examples include: evacuation notices, law enforcement actions, boil alert notices and missing child reports.

The Delaware County Emergency Management Agency encourages the use of multiple means to receive emergency communications and weather alerts:

- NOAA Weather Radio All Hazards (NWR) is a nationwide network of radio stations broadcasting
 continuous weather information directly from the nearest National Weather Service office. NWR
 broadcasts warnings, watches, forecasts and other hazard information 24 hours a day, 7 days a
 week.
- Wireless Emergency Alerts (WEA) are emergency messages sent by authorized government
 alerting authorities through your mobile carrier. Government partners include local and state
 public safety agencies, FEMA, the FCC, the Department of Homeland Security and the National
 Weather Service. No signup is required! Alerts are sent automatically to WEA-capable phones
 during an emergency.

- <u>Emergency Alert System</u> (EAS) is used by alerting authorities to send warnings via broadcast, cable, satellite, and wireline communications pathways.
- <u>Text alerts</u> from reliable sources to receive emergency communications are another way to receive information. A few good examples include: Emergency Management Agency, local television or radio, police and fire departments.
- Outdoor Warning Sirens are another great way to know if severe weather is imminent. These
 sirens are designed to be heard outdoors. They are activated for tornado warnings in Delaware
 County and are not targeted to a certain area. If you hear a siren, you should seek shelter
 immediately.
- <u>Social Media</u> is another alternative for alerts. However, be aware of who is disseminating information. *Always* rely on a reliable source.

Delaware County has recently started a Twitter & Text alert system for severe weather warnings. You can follow @delcoemawx on Twitter to receive the same alerts the EMA and some partner agencies receive. Another option is to "fast follow" @delcoemawx on your phone to receive the same warnings via text message. To receive alerts send "follow @delcoemawx" to 40404. This is a free service. However, standard texting rated apply. These alerts are for Delaware County only.
