

City of Powell, Ohio ORDINANCE 2018-47

Adopted October 16, 2018

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AMENDED AND RESTATED CENTRAL OHIO HEALTH CARE CONSORTIUM JOINT SELF-INSURANCE AGREEMENT FOR THE PURPOSE OF RETAINING MEMBERSHIP IN SUCH JOINT SELF-INSURANCE PROGRAM TO PROVIDE HEALTH CARE BENEFITS, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Powell Council hereby determines it is in the best interest of the City to provide health insurance coverage for City staff by entering into a contract for the purpose of being a member of a joint self-insurance program to provide health care benefits, pursuant to Section 9.833 of the Revised Code; and

WHEREAS, Council desires to authorize the City Manager to enter into such an agreement with the Central Ohio Health Care Consortium;

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

<u>Section 1:</u> That the City Manager is hereby authorized and directed to enter into an Amended and Restated Joint Self-Insurance Agreement with the Central Ohio Health Care Consortium, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

<u>Section 3</u>: That this Ordinance is declared to be emergency legislation, necessary for the immediate preservation of the public peace, health, and safety, such emergency arising from the need to timely meet the premium deadlines so as not to incur unnecessary penalties as well as to offer uninterrupted coverage to City employees. **WHEREFORE**, this Ordinance shall take effect and be in force from and after its passage.
