

City of Powell, Ohio ORDINANCE 2015-48

Adopted October 20, 2015

AN ORDINANCE REPEALING SECTION 181.02(b)(6) OF THE POWELL CITY ORDINANCES REGARDING AN EXEMPTION FOR INCOME TAX ON INDIVIDUALS UNDER EIGHTEEN

WHEREAS, the laws of the State of Ohio are amended from time to time making changes in the Powell City Ordinances necessary; and

WHEREAS, Section 181.02(b)(6) sets forth an exemption on income tax for individuals under the age of eighteen (18); and

WHEREAS, upon the recommendation of the Finance Director, Council desires to repeal Section 181.02(b)(6) before the adoption of the new income tax code takes effect to comply with the requirements and deadline of House Bill 5.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That Section 181.02(b)(6) of the Codified Ordinances regarding an exemption for individuals under eighteen (18) to pay income tax is hereby repealed.

Section 2: All prior ordinance(s) or any part thereof, which is(are) inconsistent with this ordinance is (are) hereby repealed as to the inconsistent part(s) thereof and the remainder of said ordinance(s) not inconsistent with this ordinance shall remain in full force and effect.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and related to the passage of this Ordinance were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Powell which resulted in such formal action were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
