

ORDINANCE 2020-05 Adopted April 21, 2020

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH PRIME CONSTRUCTION MANAGEMENT AND SURVEY FOR CONSTRUCTION ADMINISTRATION AND INSPECTION SERVICES FOR THE SAWMILL PARKWAY RESURFACING PROJECT (DELCR609-2.24, PID105806, AGREEMENT NO. 34739), AND DECLARING AN EMERGENCY.

WHEREAS, the City has been granted financial assistance through the Ohio Department of Transportation ("ODOT") for the Sawmill Parkway Resurfacing Project; and

WHEREAS, in accordance with the terms of the agreement with ODOT, the City is required to hire a construction administration and inspection services company.

WHEREAS, the City desires to contract with Prime Construction Management and Survey to perform construction administration and inspection services for the Sawmill Parkway resurfacing project.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: The City Manager is hereby authorized to enter into an agreement with Prime Construction Management and Survey, in a form substantially similar to the agreement attached hereto as Exhibit A and incorporated herein by reference, for the construction administration and inspection services of the Sawmill Parkway Resurfacing Project.

Section 2: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of the Council and any of the decision making bodies of the City of Powell which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 3: That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the City and its inhabitants for the reason that there exists an imperative necessity to begin this project; **WHEREFORE**, this Ordinance shall take effect and be in force from and after its passage.
