

ORDINANCE 2021-27

AN ORDINANCE AUTHORIZING THE CREATION OF THE AMERICAN RESCUE PLAN ACT -CORONAVIRUS LOCAL FISCAL RECOVERY FUND; AND TO APPROPRIATE MONIES FROM THE CORONAVIRUS LOCAL FISCAL RECOVERY FUND, A SUPPLEMENTAL APPROPRIATION; AND DECLARING AN EMERGENCY.

WHEREAS. Funds from the American Rescue Plan Act - Coronavirus Local Fiscal Recovery Funds have been allocated to Ohio Non-Entitlement Units of Local Government to assist municipalities in bolstering their local economy into recovery; and

in order to properly account for the City's allocation of these grant dollars, which amount to \$1,401,045.42 over the next two calendar years, the funds will be accounted for through the Coronavirus Local Fiscal Recovery Fund (CLFRF): and

WHEREAS. Council hereby determines that it is necessary to modify appropriations for the calendar year 2021 to account for the City's allocation of CLFRLF Funds:

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

That the City Finance Director is hereby authorized to establish the Coronavirus Local Fiscal Recovery Fund (CLFRF) (Fund 266).

Section 2: That Council hereby modifies its appropriations for the calendar year 2021 by supplemental appropriation: (Fund 266) \$700,522.71, the balance to be appropriated at a later date in 2022;

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 4: This ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, in that it is in the best interest of the City of Powell to immediately begin its downtown planning process. This ordinance shall, therefore, take effect and be in force immediately upon passage.
