#### Section I – Project Description

**WHEREAS**, the City of Powell has determined the need for the Bridge Inspection Program Services, including, but not limited to bridge load rating calculations, scour assessments, bridge inspections, and fracture critical plan development.

## NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

#### Section II - Consent Statement

Being in the public interest, the City of Powell gives consent to the Director of Transportation to complete the above described project.

#### Section III - Cooperation Statement

The City of Powell shall cooperate with the Director of Transportation in the above described project as follows:

The State shall assume and bear 100% of all of the cost for Bridge Inspection Program Services requested by the City and agreed to by the State. Eligible Bridge Inspection Services are described in the Consultant's Scope of Services Task Order Contract (Exhibit A).

The City of Powell agrees to pay 100% of the cost of those features which are not included in Exhibit A.

#### Section IV – Utilities and Right-of-Way Statement

The City of Powell agrees that all right-of-way required for the described project will be made available in accordance with current State and Federal regulations.

#### Section V Authority to Sign

I, Steve Lutz, City Manager of said City of Powell is hereby empowered on behalf of the City of Powell to enter into contracts with the Director of Transportation which is necessary to complete the above described project.

That Resolution 2016-20 shall take effect and be in force from and after the earliest period allowed by law.

By unanimous consent, Resolution 2016-20 was adopted.
