



RESOLUTION 2021-27

A RESOLUTION AUTHORIZING THE APPROVAL OF THE TENTATIVE AGREEMENTS ACHIEVED IN COLLECTIVE BARGAINING BETWEEN FRATERNAL ORDER OF POLICE, OHIO LABOR COUNCIL, INC. AND THE CITY OF POWELL, OHIO, FOR THE OFFICERS' UNIT AND AUTHORIZING THE CITY MANAGER TO TAKE ALL NECESSARY AND APPROPRIATE ACTIONS TO FINALIZE THE COLLECTIVE BARGAINING AGREEMENTS NEGOTIATED BETWEEN THE PARTIES.

WHEREAS, the City of Powell, Ohio and Fraternal Order of Police, Ohio Labor Council, Inc. engaged in negotiations for a renewed contract and achieved a tentative agreements regarding full contract settlement for the Officers' Unit for the period January 1, 2022 through December 31, 2022; and

WHEREAS, the tentative agreements achieved by the parties was presented to the Council of the City of Powell, Ohio for approval consistent with Chapter 4117 of the Ohio Revised Code.

NOW THEREFORE BE IT RESOLVED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:


Section 1: That this Resolution authorizing the acceptance of the tentative agreements reached by the parties in collective bargaining between the City of Powell and Fraternal Order of Police, Ohio Labor Council, Inc. for the bargaining unit consisting of Officers, is hereby approved.

Section 2: That the City Manager shall be authorized to take any and all necessary steps and appropriate actions to finalize the collective bargaining agreements consistent with the terms of the negotiated tentative agreements.



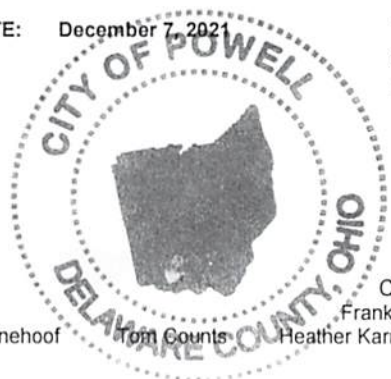
Section 4: That this Resolution shall take effect at the earliest possible date permitted by law.
