



RESOLUTION 2023-14

A RESOLUTION AUTHORIZING THE CITY TO ACCEPT THE REPORTS AND RECOMMENDATIONS OF THE POWELL TAX INCENTIVE REVIEW COUNCIL.

WHEREAS, Council has designated areas of the City of Powell as Tax Increment Financing (TIF) districts pursuant to the Ohio Revised Code Section 5709.40, and has established Tax Incentive Review Council (TIRC) pursuant to the Ohio Revised Code Section 5709.883 to annually review the TIF program; and

WHEREAS, the purpose of the Powell TIF Districts is to provide the community with effective tools for managing and guiding economic development by enhancing the tax base, by encouraging and sustaining long-term investment in the community, by enhancing the quality of life, and by preserving existing and attracting new business investment within the designated districts and areas; and

WHEREAS, the duly appointed TIRC is mandated to review all exemptions from property taxation resulting from the declaration of public purpose improvements, and make a formal recommendation as to the compliance with the terms of each exemption and/or agreement, on an annual basis for the preceding year that concluded on December 31, 2022; and

WHEREAS, the recommendations of TIRC are required to be forwarded to Council within 60 days of making the recommendation and Council is required to act upon those recommendations.

NOW THEREFORE BE IT RESOLVED BY THE CITY OF POWELL, COUNTY OF DELAWARE, STATE OF OHIO, AS FOLLOWS:


Section 1: Council hereby finds and determines that the TIRC, which is required to review exemptions and/or agreements as of December 31, 2022, has done so and has forwarded its recommendations to Council.

Section 2: That the TIRC review and recommendations made by the Delaware County/City of Powell/Olentangy School District on April 20, 2023, as summarized below, be and hereby are accepted by Council

- a. Powell Downtown Area TIF: TIF areas are in compliance and recommended for continuation;
- b. Powell Sawmill Commercial TIF: TIF areas are in compliance and recommended for continuation;
- c. Powell Seldom Seen TIF: TIF areas are in compliance and recommended for continuation.




