

New Business Checklist

We hope this checklist makes it easier for you to get your new business up and running in the City of Powell. Every business needs one or more federal, state, or local licenses or permits to operate. Licenses can range from basic operating licenses to very specific permits (e.g. environmental permits) depending on your business needs. If you need help completing your business permits, feel free to reach out to the Development Department. We are happy to meet with you and help walk you through the permitting process. Permit applications need to be submitted through the Building Department at 47 Hall Street, and will be reviewed in the order they are received within 30 days. The following are common types of local permits and licenses:

☐ Change of Occupancy Permit OR Building Permit

A Change of Occupancy application is required only if NO ALTERATIONS are part of the project. If any changes are to be made to the building, a Building Permit is required instead. A building permit will need to be submitted if you are constructing or modifying your place of business. A permit is required for any plumbing, mechanical and/or electrical work.

□ Contractor Registration

The City requires all contractors (general contractors and trades) to register for any work done within City limits. If you are planning to alter a building, your contractor needs to be registered. All contractor registrations expire December 31 of the year issued and must be renewed in order to continue to do work in the City of Powell.

If you are planning to run a business out of your home, you are required to submit a Residential Zoning Certificate Application.

Commercial Sign Permit A Commercial Sign Permit needs to be submitted for any new permanent sign to be installed. Commercial temporary signs are NOT allowed in the City, this includes stick signs, sandwich board signs, banners, etc.

Liquor License If you are planning to sell liquor at your business, you need to apply for a Liquor Permit through Ohio Division of Liquor Control.
