- 5) The following statement: "APPLICANT ACKNOWLEDGES THAT APPLICANT IS SOLELY RESPONSIBLE FOR THE ENGINEERING AND CONSTRUCTION OF THE PREMISES SET FORTH IN THIS APPLICATION AND APPLICANT FOR APPLICANT, APPLICANT'S HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS SPECIFICALLY RELEASES THE CITY OF POWELL FROM ANY AND ALL CLAIMS RELATING TO THE DESIGN, CONSTRUCTION, AND PLACEMENT OF THE STRUCTURES THE SUBJECT OF THIS APPLICATION;
- 6) Letter of approval from the Delaware County Health Department and/or the Environmental Protection Agency of the proposed method of disposal of sanitary wastes in every case where the property is not served by a public sewer.
