**ORDINANCE 2015-24**  
Adopted June 16, 2015

**AN ORDINANCE APPROVING A ZONING MAP AMENDMENT FOR 7.226+/- ACRES AT LOTS 5124 & 5125 AT LIBERTY CROSSING FROM LIBERTY TOWNSHIP PC, PLANNED COMMERCIAL DISTRICT TO CITY OF POWELL PC, PLANNED COMMERCIAL DISTRICT.**

**WHEREAS,** at their meeting on May 13, 2015, the Planning and Zoning Commission of the City of Powell having recommended approval of the Zoning Map Amendment for 7.226+/- acres at Lots 5124 & 5125 at Liberty Crossing, changing the existing zoning from Liberty Township PC, Planned Commercial District to City of Powell PC, Planned Commercial District; and

**WHEREAS,** the Zoning Map Amendment has been submitted to Council by the Planning and Zoning Commission pursuant to the provisions of Section 1131.11 of the Codified Ordinances of Powell; and

**WHEREAS,** Council has determined the implementation and approval of the Zoning Map Amendment, a legal description of which is attached hereto and incorporated herein by reference as Exhibit "A" is in the best interest of the residents of the City of Powell;

**NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:**

**Section 1:** That the Zoning Map Amendment for 7.226+/- acres at Lots 5124 & 5125 at Liberty Crossing, a legal description and Preliminary Development Plan, of which is attached hereto and incorporated herein by reference as Exhibit "A" is accepted and approved by the Council of the City of Powell. The Director of Development shall change the zoning map for the subject parcel from Liberty Township PC, Planned Commercial, District to City of Powell PC, Planned Commercial District; and

**Section 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

**Section 3:** That this Ordinance shall take effect on the earliest period allowed by law.

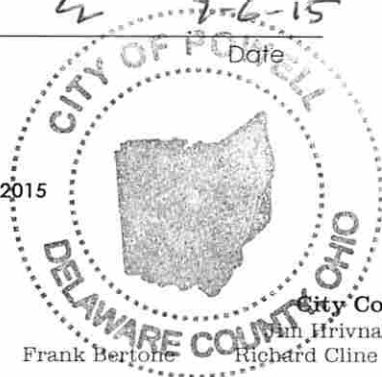


