RESOLUTION 2016-16

Adopted August 2, 2016

A RESOLUTION TO AUTHORIZE THE CITY MANAGER TO FILE AN APPLICATION WITH THE MID-OHIO REGIONAL PLANNING COMMISSION (MORPC) FOR THE PURPOSE OF ACQUIRING FUNDS FOR RESURFACING SAWMILL PARKWAY AND FOR MAKING SPOT REPAIRS AS NEEDED TO THE PARALLEL ADJACENT MULTI-USE TRAIL.

WHEREAS, the Ohio Department of Transportation (ODOT) sub-allocates federal transportation funding via the *MPO and Large Cities Capital Program*, and

WHEREAS, the Mid-Ohio Regional Planning Commission (MORPC) is the local Metropolitan Planning Organization (MPO), and

WHEREAS, funds sub-allocated to MORPC are collectively called MORPC-attributable funds, and

WHEREAS, the MORPC-attributable funds includes the System Preservation category of the Surface Transportation Program (STP), and

WHEREAS, the STP provides flexible funding that may be used by states and localities for projects to preserve and improve the conditions and performance on any public road, pedestrian and bicycle infrastructure, and

WHEREAS, the City of Powell, Ohio is eligible for and desires to pursue financial assistance through MORPC for the resurfacing of Sawmill Parkway between Seldom Seen Road and Home Road, and for making spot repairs as needed to the parallel adjacent multi-use trail with an estimated project cost of \$1,940,442 and with an estimated construction cost of \$1,617,035; and

WHEREAS, the estimated cost to the City of Powell is \$543,324 (100% of the design cost and 20% of the construction cost), and

WHEREAS, under the oversight of the Attributable Funds Committee (AFC), MORPC conducts a process every two years to solicit applications for funding, evaluate the proposed projects, and commit funds to those selected, and

WHEREAS, Surface Transportation Program (STP) funding applications are due by August 15, 2016;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That the City of Powell approves filing applications for financial assistance through the Mid-Ohio Regional Planning Commission for resurfacing of Sawmill Parkway between Seldom Seen Road and Home Road and for making spot repairs as needed to the parallel adjacent multi-use trail.

Section 2: That the City Manager is hereby authorized and directed on behalf of the City of Powell to execute and file an application with the Mid-Ohio Regional Planning Commission and to provide all information and documents required to become eligible for possible funding assistance.

Section 3: That the City of Powell does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under terms and conditions of the Mid-Ohio Regional Planning Commission for the System Preservation category of the Surface Transportation Program (STP) Funding Program.

Section 4: That it is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Resolution were adopted in an open meeting of the Council and that all deliberations of this Council and any of the decision making bodies of the City of Powell which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 5: That this Resolution shall take effect at the earliest possible date permitted by law.

By unanimous consent, Resolution 2016-16 was adopted.

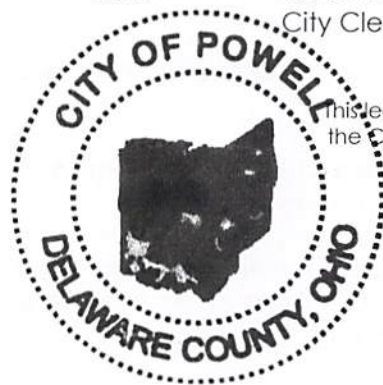
