AN ORDINANCE AMENDING CHAPTER 1339 OF THE CODIFIED ORDINANCES FOR THE CITY OF POWELL REGARDING SWIMMING POOLS.

WHEREAS, the City's Chief Building Official recommends updating the swimming pools regulations and add regulations for spas and hot tubs and to incorporate Appendix G of the 2009 ICC International Residential Code; and

WHEREAS, Council desires to adopt the recommendations of the Chief Building Official and amend Chapter 1339 of the Codified Ordinances of the City of Powell;

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:


Section 1. That Chapter 1339, Swimming Pools is hereby amended to read as set forth on the document attached hereto as Exhibit "A" and incorporated herein by reference.

Section 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 3. That this Ordinance shall take effect at the earliest period allowed by law.

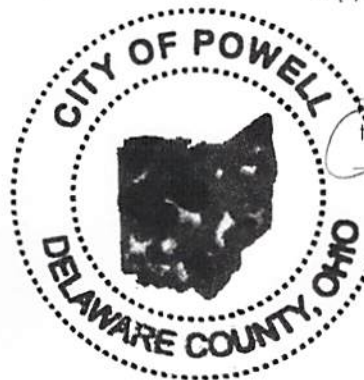
