ORDINANCE 2016-42
Adopted October 4, 2016

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH THE LIBERTY TOWNSHIP TRUSTEES FOR THE PURPOSE OF ENTERING INTO A JOINT MULTI-USE PATHWAY IMPROVEMENT PROJECT IN AN UNINCORPORATED AREA OF LIBERTY TOWNSHIP ALONG NORTH LIBERTY ROAD KNOWN AS THE RUTHERFORD ROAD TRAIL SECTION AND DECLARING AN EMERGENCY.

WHEREAS, the City and Liberty Township have identified the need for improved pedestrian and bike path connectivity for residents around the City and surrounding county; and

WHEREAS, Liberty Township has proposed the extension of a Multi-Use Pathway in an unincorporated area of Liberty Township along North Liberty Road and known as the Rutherford Road Trail Section and connected to an existing multi-use path in the City of Powell; and

WHEREAS, the City and Liberty Township desire to enter into an agreement for the construction of the Multi-Use Pathway in an unincorporated area of Liberty Township along North Liberty Road known as the Rutherford Road Trail Section in order to offer consistent and efficient pathways to provide for the public health, safety, and welfare of the community;

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That the City Manager is hereby authorized and directed to enter into a Joint Multi-Use Pathway Improvement Project Agreement with the Liberty Township Trustees in a form substantially similar to the Agreement attached hereto as Exhibit "A" and incorporated herein by reference.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 3: That this Ordinance is hereby declared to be an emergency measure, necessary for the preservation of the public health, safety and welfare, such emergency arising from the City's desire to commence joint advertising and bidding; wherefore, this ordinance shall take effect and be in force from and after its passage.
