ORDINANCE 2017-06

Adopted February 21, 2017

AN ORDINANCE TO AMEND SECTION 1(4) OF ORDINANCES 2013-13 AND 2015-27 SETTING FORTH CERTAIN REQUIREMENTS FOR THE DESIGN OF THE MURPHY PARKWAY EXTENSION SOUTH PROJECT.

WHEREAS, Council previously set forth certain requirements for the design of the Murphy Parkway Extension South project as it connects to Liberty Road in Ordinances 2013-13 and 2015-27; and

WHEREAS, Council desires to amended Section 1(4) of Ordinances 2013-13 and 2015-27 with regard to traffic impacts on adjoining streets to Murphy Parkway to determine if further traffic calming measures are necessary and, in an effort to get the most accurate analysis, desire to conduct this study when traffic flow is not impacted by other construction projects in the area;

NOW THEREFORE BE IT ORDAINED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That Section 1(4) of Ordinances 2013-13 and 2015-27 are hereby amended to read as follows:

That Council hereby establishes the following design criteria for the Murphy Parkway Extension South project, based upon all previous studies that have been done for this Extension, current best engineering practices, and in keeping with the policies established by Council within the Comprehensive Plan and any amendment thereto:


1. That the Murphy Parkway Extension South shall "T" into Liberty Road, as generally shown on the attached Exhibit "A."
2. That prior to construction of Murphy Parkway Extension South, traffic studies shall be performed, as directed by the City Engineer, so that impacts can be measured upon adjoining streets to Murphy Parkway.
3. That Murphy Parkway shall be designed to incorporate the ability to provide future access management, and/or other traffic calming measures, that shall be designed to decrease negative impacts upon adjoining neighborhoods.
4. City Council will re-examine the traffic impacts on adjoining streets to Murphy Parkway to determine if further traffic calming measures are necessary. The City Engineer shall be authorized to utilize his discretion as to when he conducts this study in 2017.
5. That the Liberty Street at-grade rail crossing shall remain open.
6. That within 180 days of the opening of Murphy Parkway to the south, the City Council will review the landscaping that has been installed and determine if additional landscaping is necessary.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 3: That this Ordinance shall take effect on the earliest possible date permitted by law.

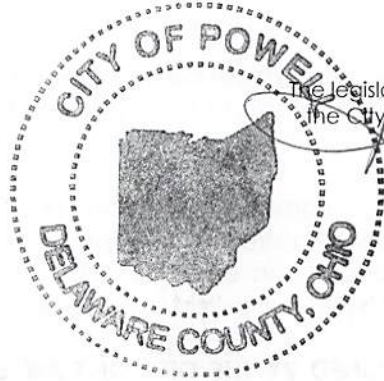
