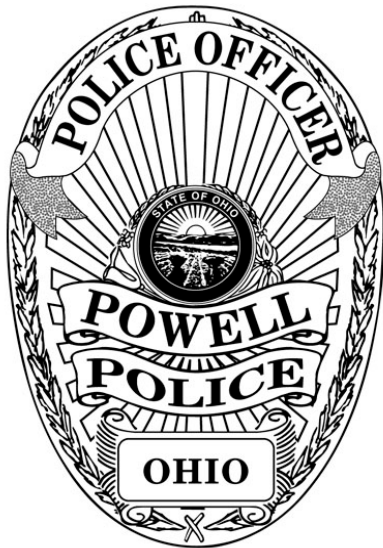

NOTABLE CASES

Breaking & Entering | Four businesses in Liberty Plaza were broken into on June 17th. Another break in on Powell Road was linked to these cases. No prints were found.

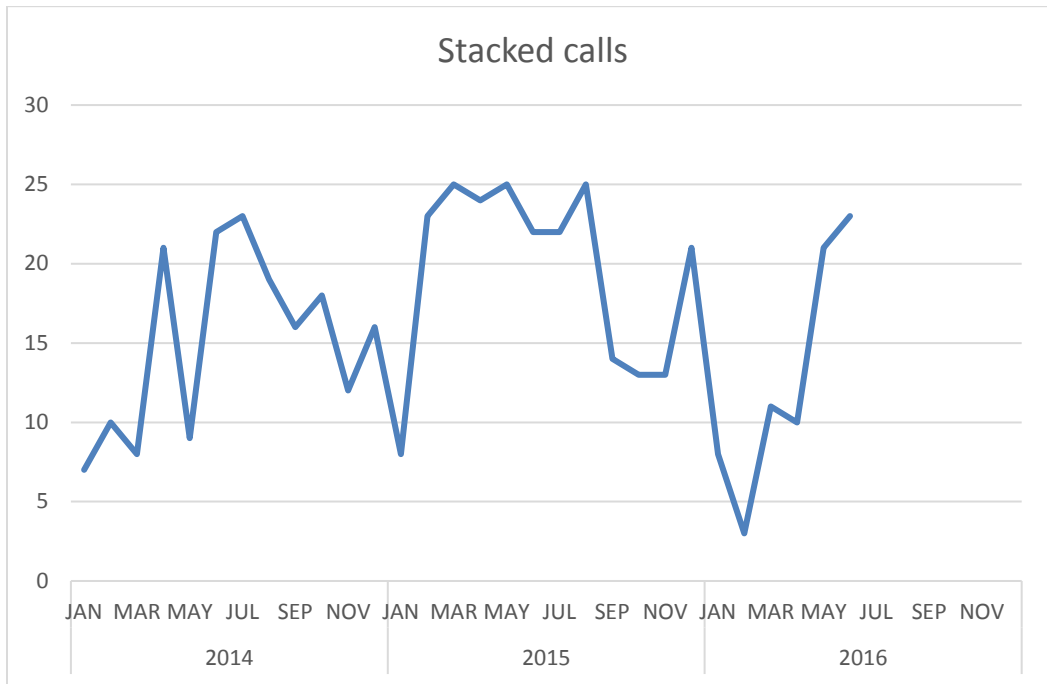

TRAINING

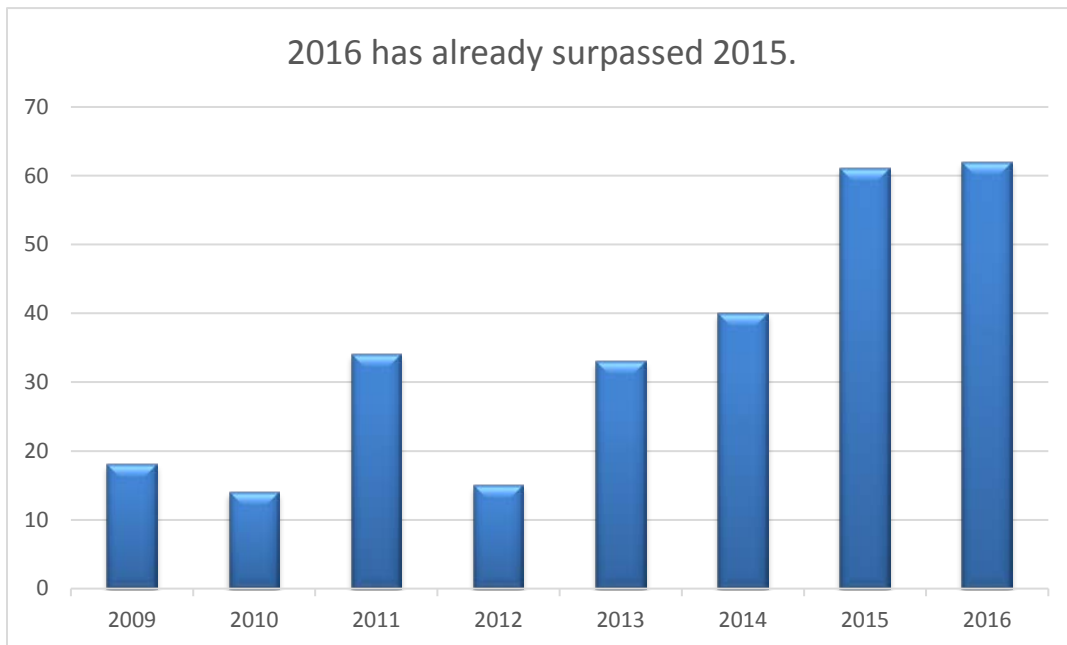
In June the department completed 116 hours of training including **Policing in the 21st Century, Ohio Public Records, Ohio Tactical Officers Conference, National Association of**

STACKED CALLS

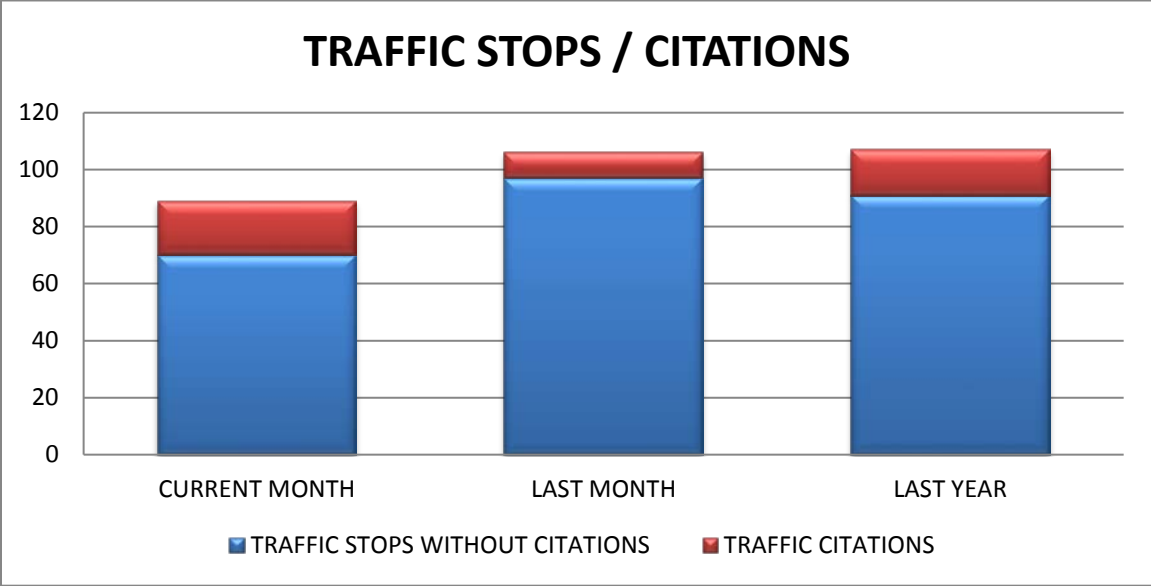


PEDDLER PERMITS

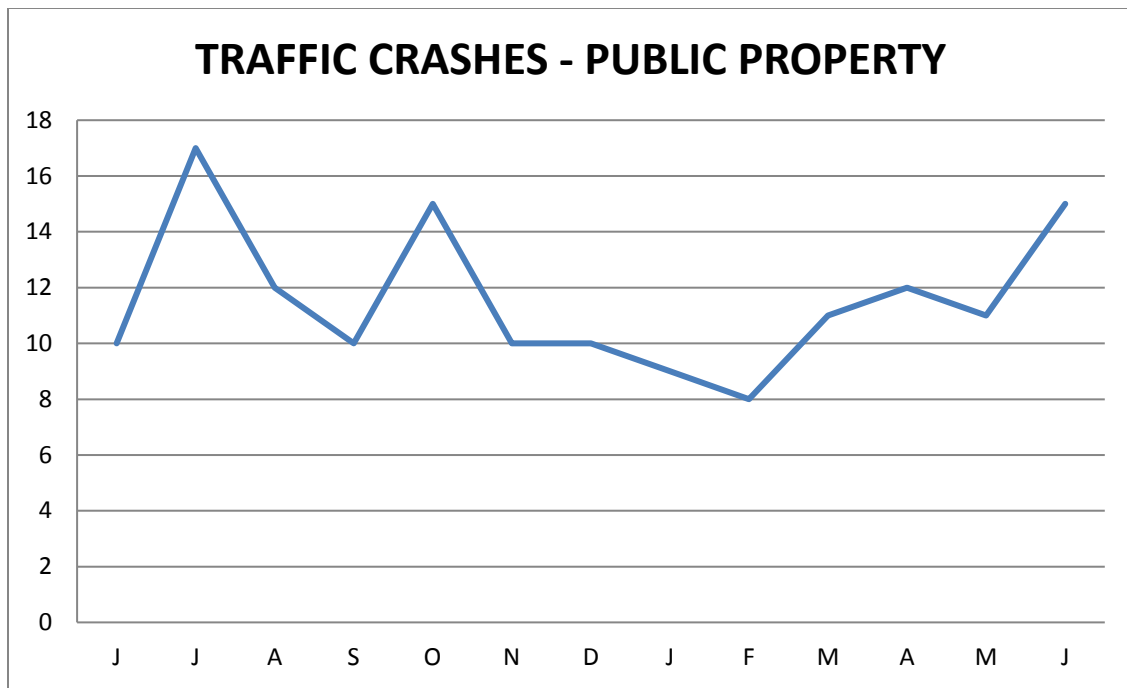


Three peddler permits were pulled due to aggressive tactics, soliciting after hours, and failure to wear the permit.

TRAFFIC CRASHES – PUBLIC PROPERTY

- 6/3/2016 **ACDA** | *Injuries* | Units 1 and 2 were northbound on Sawmill Parkway at Market Street. Unit 2 stopped for traffic in the roadway from geese crossing. Unit 1, unable to stop, struck the rear of Unit 2. The driver of Unit 2 reported she was pushed into the vehicle in front of her; however, that vehicle continued on. Unit 1 was cited.

- 6/3/2016 **ACDA** | Unit 1 failed to maintain an assured clear distance ahead and as a result, struck Unit 2 from behind. At the time of the collision, both units were heading northbound on Sawmill Rd. and Unit 2 had slowed/stopped in traffic prior to being struck. Unit 1 was cited.

- 6/7/2016 **Failure to Control** | Unit 1 was turning northeast onto Middlebury Way from Village Park Dr. While turning, Unit 1 failed to control and struck Unit 2, which was parked and unoccupied on Village Park Dr, facing south. Unit 1's passenger side mirror struck Unit 2's driver's side mirror.

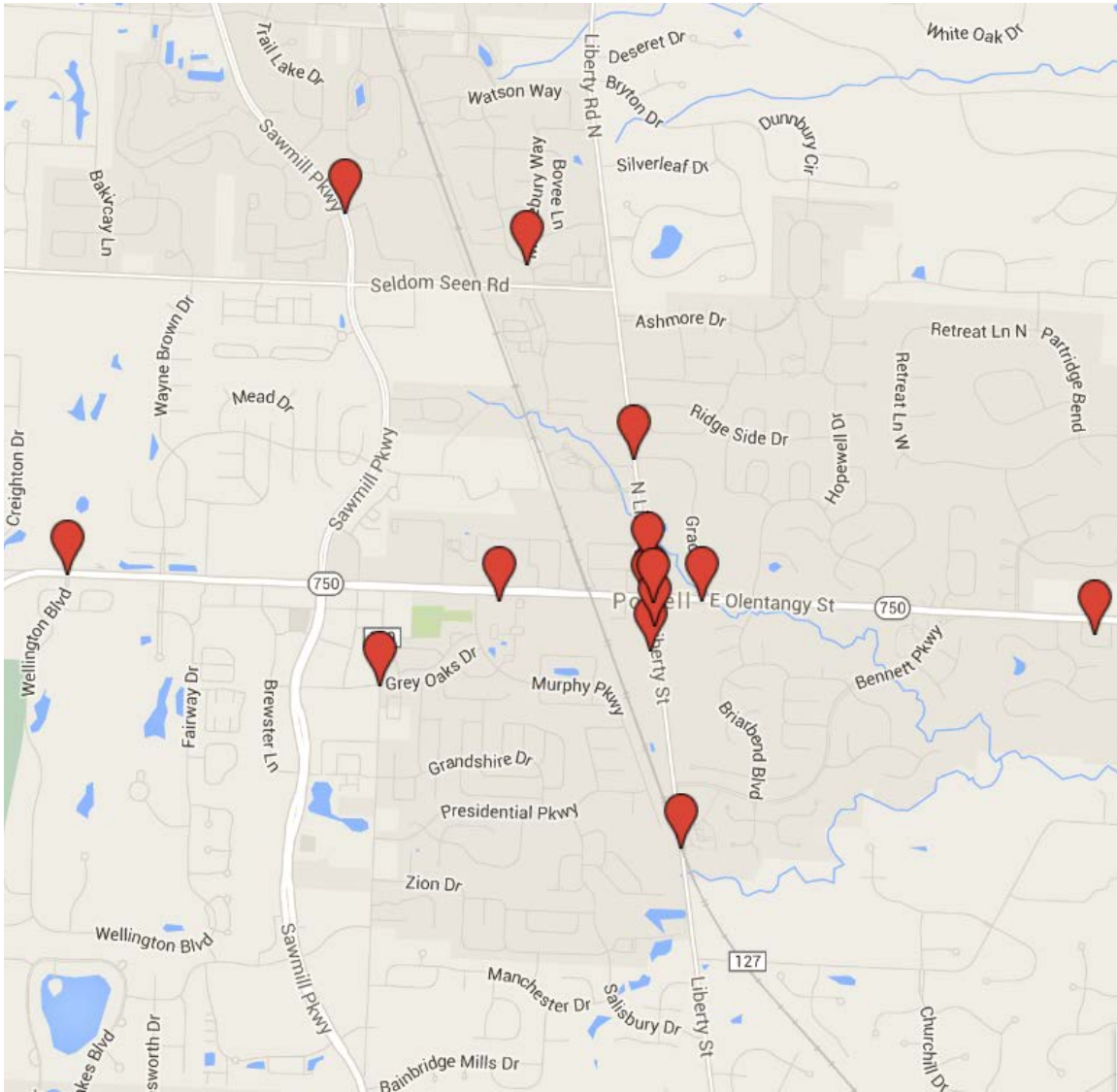
- 6/9/2016 **ACDA** | Unit 2 was traveling southbound on N. Liberty St. and stated he was about to make a right turn at the cross street onto W. Olentangy St. when he slowed/stopped to yield to pedestrians crossing. Unit 2 stated he was struck by Unit 1 in the rear of the vehicle. Unit 1 stated she was traveling directly behind Unit 2. She stated she was going to go around Unit 1 but did not get stopped.

in time to avoid crashing when she observed him slow/stop in the intersection. Unit 1 was cited.

- 6/11/2016 **OVI** | Unit 1 was traveling northbound on County Road 9, when it traveled left of center and drove off the left side of the roadway. The vehicle drove for approximately 155 feet off road, striking a sign before coming back on to the roadway. The driver was arrested for OVI after a traffic stop was conducted.
- 6/11/2016 **Hit Skip** | Unit 2 was eastbound on SR 750 approaching a red light. Unit 1 was eastbound behind Unit 2. Unit 1 entered the westbound lanes and struck Unit 2's front bumper with passenger side rear of its vehicle as it returned to the eastbound lane in attempt to avoid a head-on collision with another vehicle. Unit 1 continued through the red light and left the area.
- 6/15/2016 **ACDA** | Units 1, 2, and 3 were northbound on S. Liberty St. Units 2 and 3 stopped for traffic. Unit 1 failed to stop and struck Unit 2 pushing it into Unit 3. Unit 1 was cited.
- 6/15/2016 **ACDA** | Unit 2 was stopped in traffic, on SR 750, when Unit 1 struck Unit 2 in the rear, failing to keep assured clear distance ahead. Unit 1 was cited.
- 6/16/2016 **ACDA** | Unit 1 failed to maintain an assured clear distance ahead and as a result struck Unit 2 from behind. At the time of the collision, Unit 2 had slow/stopped in traffic, and both units were heading eastbound on SR 750. Unit 1 was cited.
- 6/16/2016 **Failure to Yield** | Unit 2 was traveling eastbound on SR 750 (E. Olentangy St.) and was slowed/stopped in traffic. Unit 1 was attempting to pull out of a private drive to make a left turn to head west bound on SR 750. Unit 1 and Unit 2 stated there was miscommunication between the two drivers using hand signals. Unit 1 began to initiate his left turn when Unit 2 began to pull forward causing the two vehicle to strike each other.
- 6/17/2016 **Failure to Yield** | Unit 2 was driving northbound on N. Liberty, when Unit 1 failed to yield the right of way on a left turn and struck Unit 2. Unit 1 was cited.
- 6/19/2016 **ACDA** | Unit 1 was stopped at a red light behind Unit 2 on E. Olentangy St. @ N. Liberty St. The driver of Unit 1 stated she was looking at her car stereo and when she looked up she thought the light had turned green. She then accelerated and struck Unit 2. Unit 1 was cited.

- 6/19/2016 **ACDA** | Unit 2 was stopped in traffic westbound on SR750 at Grace Dr. Unit 1 was also westbound on SR750, behind Unit 2. Unit 1 failed to use assured clear distance ahead and struck Unit 2. Unit 1 was cited.
- 6/27/2016 **Hit Skip** | Unit 1 was southbound on S. Liberty St. Unit 1 drove off the right side of the roadway and struck a mailbox. Unit 1 left the scene without reporting the crash.
- 6/30/2016 **ACDA** | Unit 2 was stopped on Grace Drive at the stop sign with N. Liberty St. Unit 1 was stopped behind Unit 2. Unit 2 started to make a right turn onto N. Liberty St. when an emergency vehicle came southbound through the area. Unit 2 stopped and yielded the right of way to the emergency vehicle. Unit 1 did not see the emergency vehicle or that Unit 2 had stopped and rear-ended Unit 2. Unit 1 was cited.
