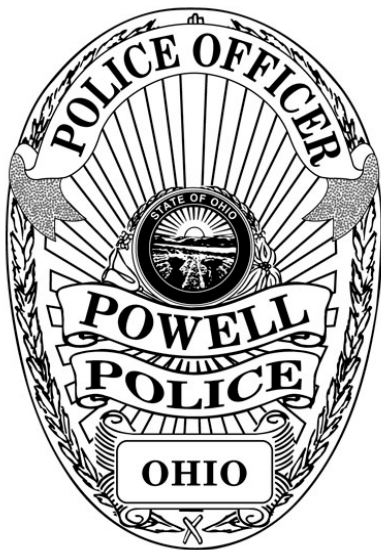

Theft | An employee of a business on Sawmill Parkway was allegedly taking cash from the store. The suspect was arrested for theft and taken to the Delaware County jail.

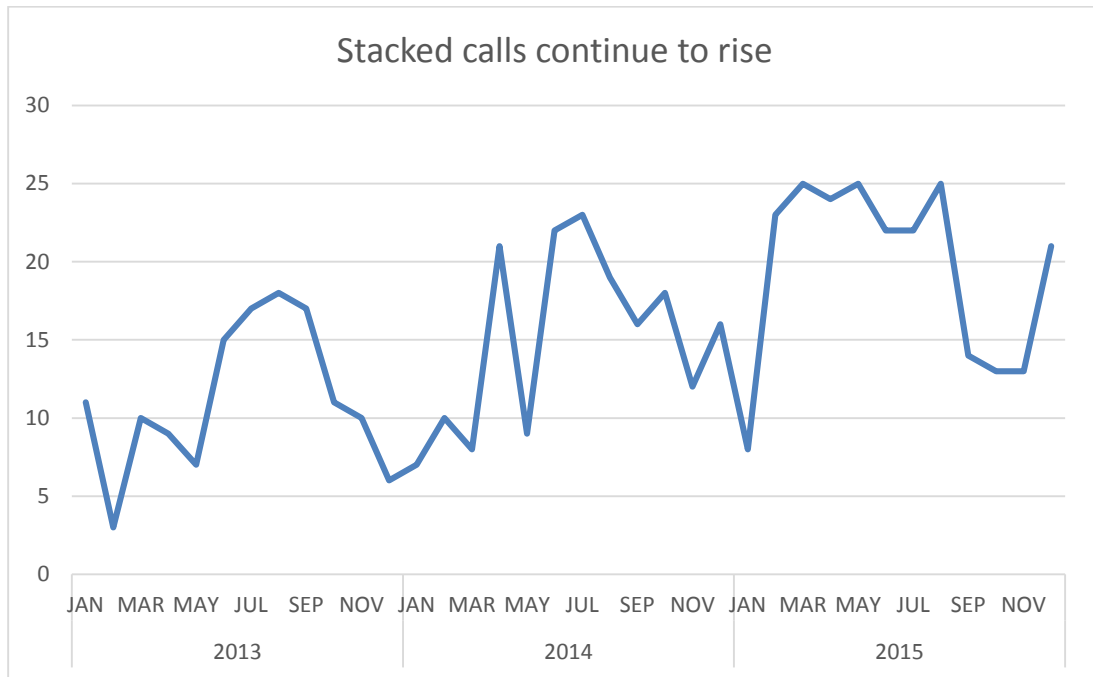

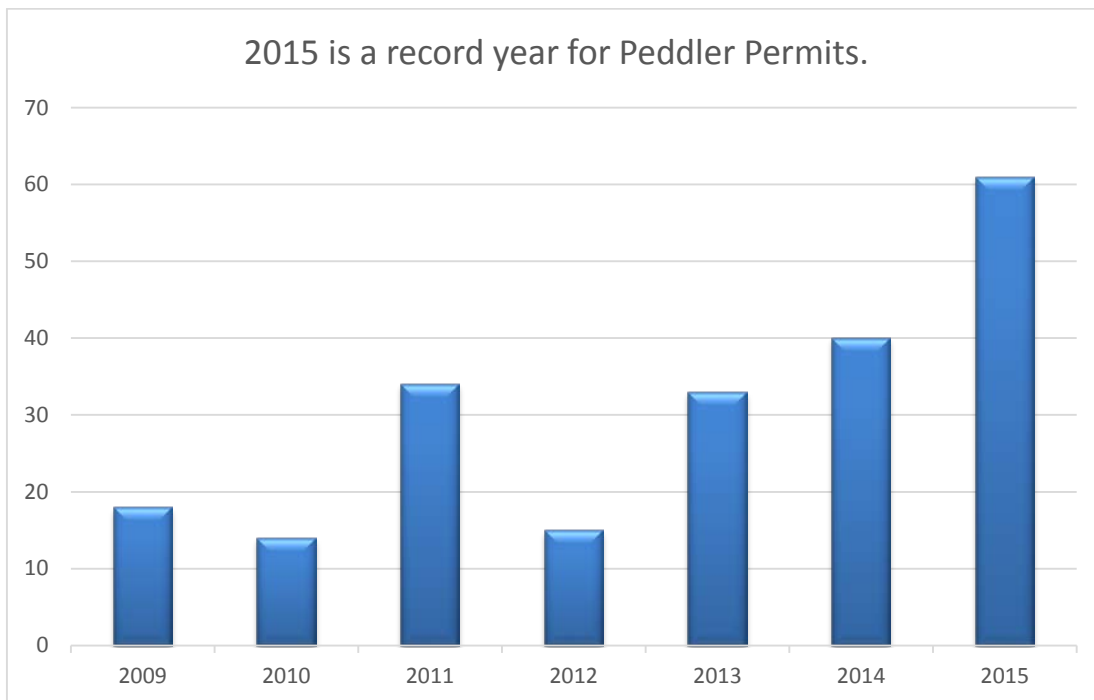

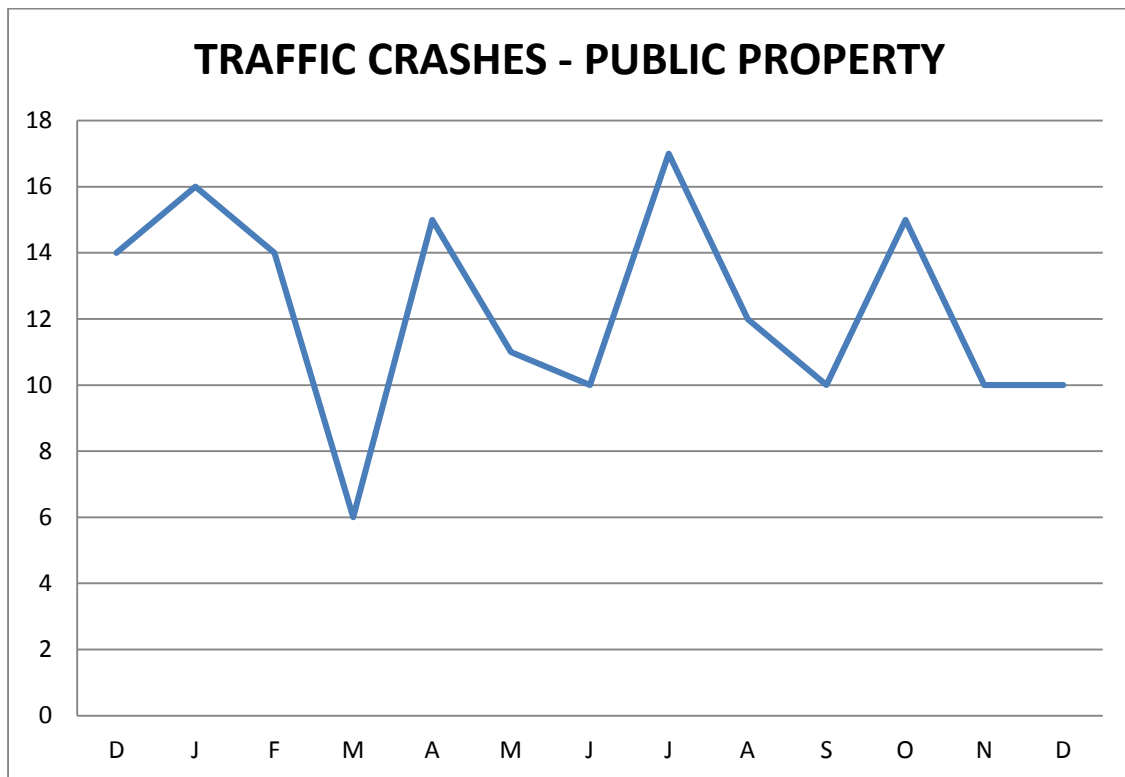
TRAINING

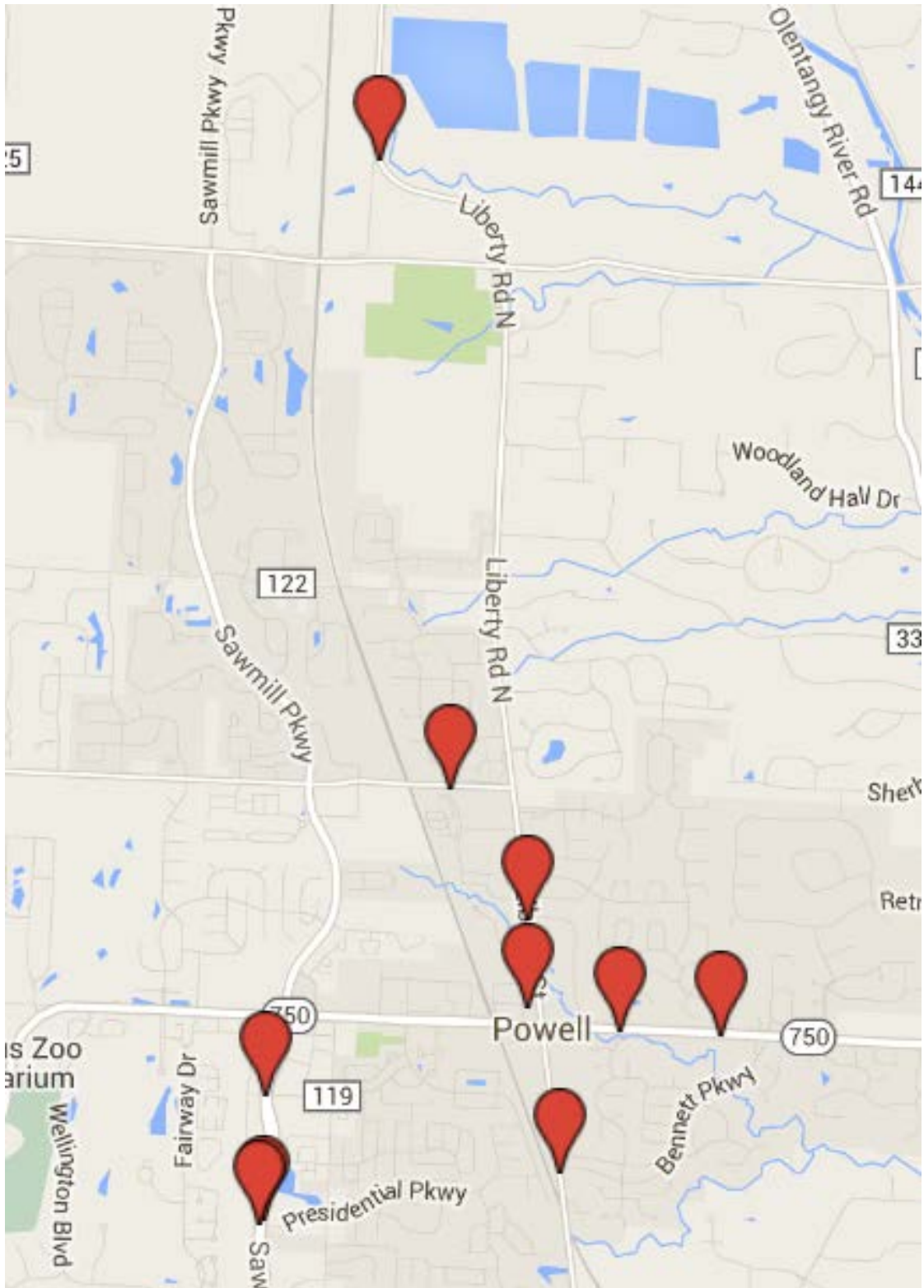

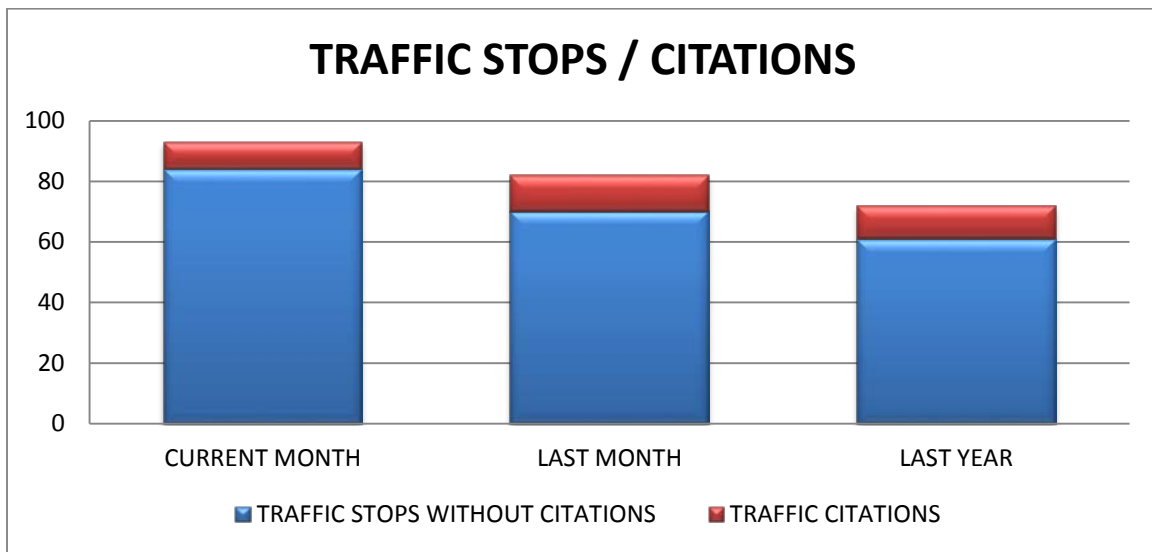
13-MONTH PATTERN OF CRASHES

Dear Chief Vest,

I am writing you this letter to convey my appreciation for your agency and, in particular, Detectives Ryan Pentz and Darren Smith.

As you know, we are conducting parallel investigations involving persons, and unfortunately police officers in Nebraska, who are believed to be using and/or distributing illegal steroids.

From the very beginning of the investigation, Detectives Pentz and Smith have been very accommodating and professional. They sacrificed their professional time as well as their personal time to ensure that my recent follow-up visit to Powell was productive and meaningful. They coordinated transportation to and from the Columbus airport and my hotel accommodations. More importantly, they outlined an investigative plan for case file and evidence review and a witness interview schedule. On Monday, December 14, 2015 we spent approximately twelve hours following up on the steroids investigation. The case file and evidence review revealed small but significant puzzle pieces as they relate to the Lincoln investigation. The telephone and personal interviews were especially helpful in providing greater context to our understanding of how the steroids were distributed, packaged and resold. And, as uncomfortable as it is, the time spent was well worth it. We have dispelled any reasonable doubt that may have existed regarding relevant conduct that has occurred in Lincoln.

I very much appreciate the professional assistance of Detectives Pentz and Smith, as well as their personal sacrifice of time and effort, to help our agency in this investigation. They are a wonderful investigative team and have earned our trust and respect. Detectives Pentz and Smith are a wonderful credit to the Powell Police Department and your community.
