Steve Lutz, City Manager: At the last City Council meeting the City unanimously approved a Pre-annexation Agreement for a proposed single-family residential development located on the east and west side of Steitz Road between Rutherford and Home Roads. The next step in this process is adopting the service resolution which is forwarded to the county informing them that the City is willing to provide municipal services for this development. This development will be going through P&Z and will be coming back to Council at a future date. Mr. Hart, who represents the developer, is here to answer questions.

Mayor Lorenz opened this item to public comment. Hearing none, he closed the public comment session.

SECOND READING: ORDINANCE 2016-63: AN ORDINANCE APPROVING THE FINAL DEVELOPMENT PLAN TO CONSTRUCT A 3.672 SQUARE FOOT ADDITION TO AN EXISTING CHILD CARE FACILITY AT 14 GRACE DRIVE.

Mr. Lutz: Tonight is the second reading of this proposed addition to the Big Hearts Little Hands child care center. Dave will give a brief review of the proposal.

David Betz, Development Director: The property is at the northeast corner of Grace Drive and Liberty Street Basically the addition fills in the center part of the existing building and puts an addition on the k h

front. The plans are attached to the ordinance that show there will be revised landscaping and sidewalk out in front. There is no need for additional parking because the existing parking meets our requirements for parking for the site. They have worked with neighbors in back for fencing and everyone is happy with the process. P&Z recommended approval.

FIRST READING: ORDINANCE 2016-68: AN ORDINANCE TO VACATE A PORTION OF A DRAINAGE EASEMENT AND A PORTION OF A LANDSCAPE BUFFER EASEMENT, LOCATED ON REAL PROPERTY OF RECORD IN PLAT CABINET 2, SLIDES 542-542A, IN THE RECORDER'S OFFICE, DELAWARE COUNTY, BEING LOT 1978, JOHN D. WOLF COMMERCE PARK SECTION 2, AND DECLARING AN EMERGENCY.	
Mr. Lutz: This is regarding the storage facility that was recently approved by City Council. As we went through the approval process, it was noted that there was a landscape buffer and drainage area on the west side of the property. As part of the development plan, you saw that it had been shifted where they had acquired some property on the east side. What this legislation will do is vacate that landscape buffer and drainage area on the west side so the developers can close on the property and there won't be those encumbrances on the property. Dave and Karen did circulate a revised exhibit that properly shows the vacated easements are there on the west side and not on both sides.

FIRST READING: ORDINANCE 2016-69: AN ORDINANCE AMENDING ORDINANCE 2010-59 TO ADD A CERTAIN PARCEL OF REAL PROPERTY TO THE DECLARATION OF PUBLIC PURPOSE MADE IN THAT ORDINANCE AND DECLARING AN EMERGENCY.

Mr. Lutz: This Ordinance adds Spectrum II to our Sawmill Parkway Tax Increment Finance District which was discussed when Spectrum II was approved. Spectrum II is the assisted living memory care facility under construction on Old Sawmill Road right now. If this is approved tonight, we will get it filed with the county tomorrow and that way it will go on the tax roll first thing next year and we capture the incremental increase.
