

NOTABLE CASES

Rape | A resident of Powell was indicted for three counts of rape, two counts of kidnapping, two counts of domestic violence, menacing by stalking, and aggravated menacing.

Thefts from Vehicles | Two suspects were apprehended after breaking into vehicles in Powell. A search warrant uncovered stolen property in their vehicle. They were charged with theft, complicity to commit theft, and criminal damaging.


Domestic | Two brothers got into a violent altercation in a parking lot on Sawmill Parkway. One brother was arrested and charged with domestic violence, criminal damaging, and disorderly conduct.

TRAFFIC CRASHES – PUBLIC & PRIVATE PROPERTY

- 2/2/17 Hit Skip | Unit 1 failed to maintain an assured clear distance ahead and as a result struck Unit 2 from behind. Unit 1 fled the scene. At the time of the crash both units were northbound on Liberty Rd.
- 2/10/17 ACDA | Unit 2 was stopped in traffic westbound on E. Olentangy St. in front of 50 E. Olentangy St. Unit 1 was behind Unit 2 in traffic, also westbound. Unit 1 failed to use assured clear distance ahead and struck Unit 2. Unit 1 was cited.
- 2/13/17 **Failure to Control** | Unit 1 was northbound on Bennett Pkwy at SR 750. Unit 1 failed to control their vehicle and struck a pole at the intersection before continuing east onto SR 750.
- 2/17/17 **Backing** | Unit 2 was parked in a parking spot and unoccupied. Unit 1 struck Unit 2 while attempting to back up.

- 2/18/17 Failure to Yield | Unit 1 was turning left on S. Liberty St to head southbound. Unit 2 was stopped before the entrance to 50 S Liberty, waiting on the backed up traffic at the red light. Unit 1 started pulling out to make the left turn and hit Unit 2, which had moved up once the light turned green.
- 2/21/17 **Hit Skip** | Unit 2 was parked and unoccupied in the parking lot of Tyler Run Elementary. Unit 1 which was parked just to the West of Unit 2 pulled out of the parking space and misjudged the proximity of Unit 2. Unit 1 struck Unit 2. This narrative was confirmed by watching video recorded at the incident location.
- 2/22/17 **Deer** | Unit 1 was traveling southbound on Sawmill Pkwy, when a deer walked out into the roadway and was struck by Unit 1 after passing the intersection of Village Club.
- 2/23/17 **Backing** | Unit 1 was backing out of a parking spot at 10158 S. Liberty St. and struck Unit 2, which was parked and unoccupied.
- 2/25/17 Marked Lanes | Unit 1 was traveling westbound on State Route 750 and Unit 2 was traveling eastbound on State Route 750. Near the intersection of Sycamore Ridge Dr., Unit 1 crossed over the center line and sideswiped Unit 2. Unit 1 was cited.
- 2/28/17 ACDA | Unit 1 and Unit 2 were both traveling eastbound on State Route 750. Unit 2 had come to a stop in traffic east of Valley Run Dr. and was waiting to turn north into a drive way, when Unit 1 failed to maintain assured clear distance ahead and struck Unit 2 in the rear. Unit 1 was cited.


