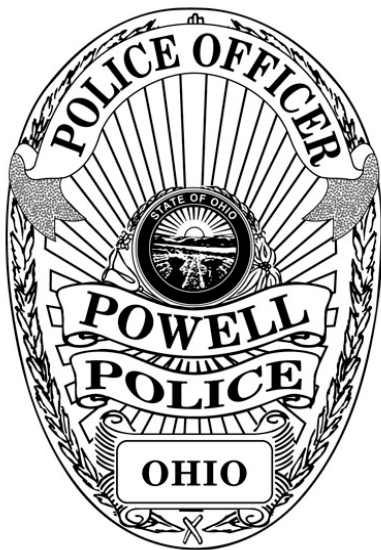

TRAINING

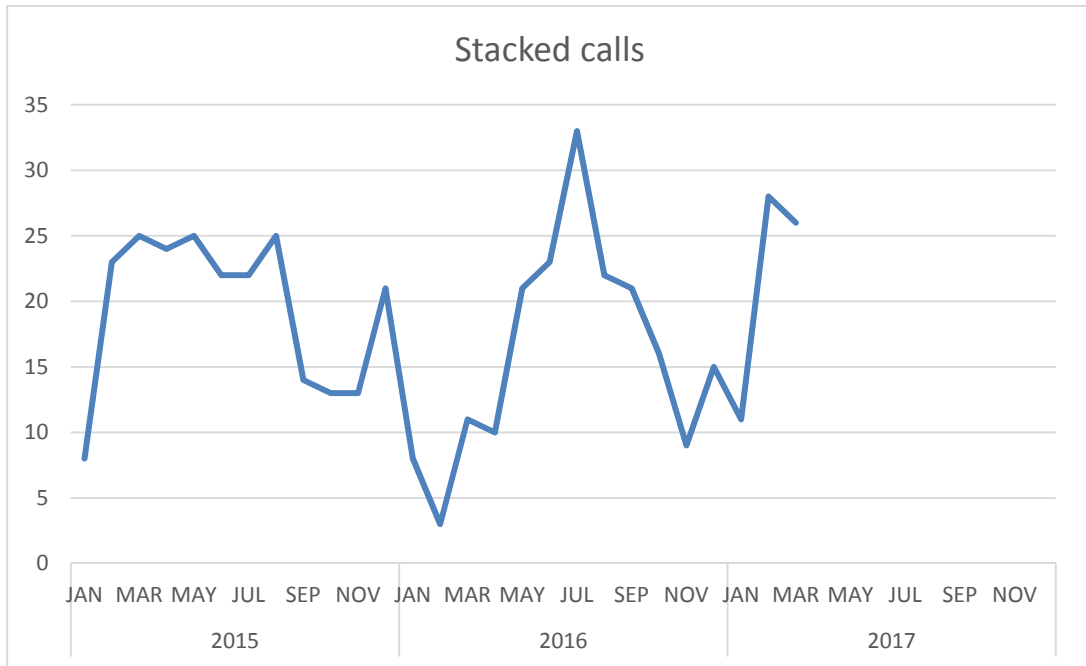

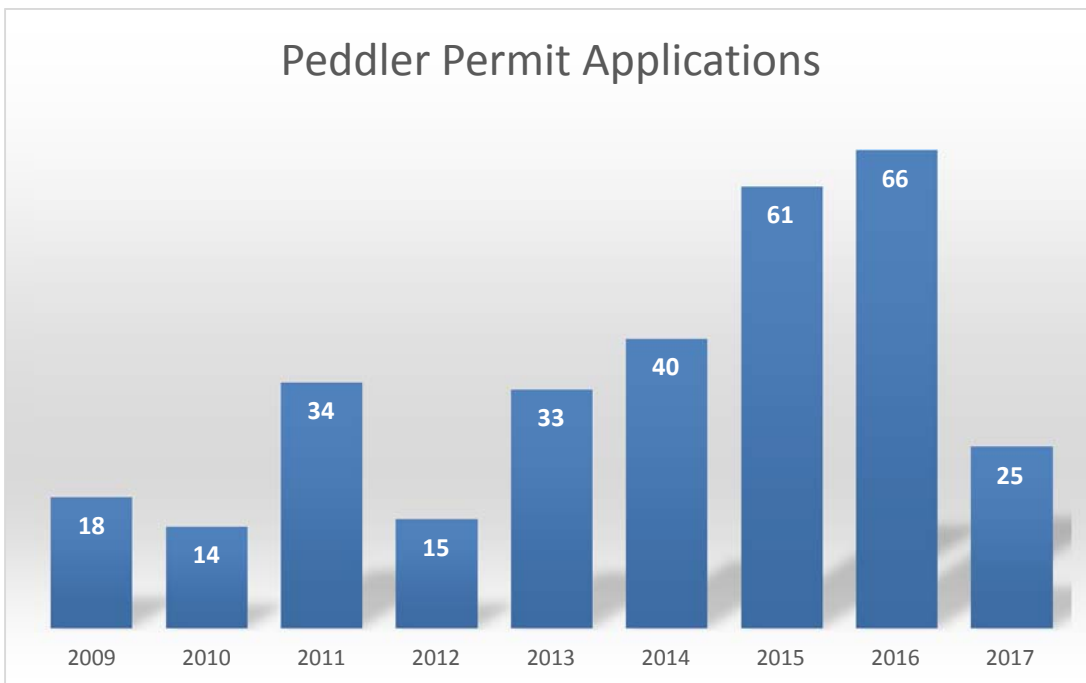

NOTABLE CASES

Theft | More than \$10,000 in jewelry was stolen from a downtown business. A suspect was identified by fingerprints, and the investigation is being pursued.

Burglary | One suspect was apprehended after allegedly stealing from a home on Francine Lane. A car was impounded, and stolen property was found by a search warrant. Additional suspects are being investigated, and charges are pending.

Bad Checks | A suspect is being investigated for presenting multiple fraudulent checks to a local bank totaling \$15,000.

TRAFFIC CRASHES – PUBLIC & PRIVATE PROPERTY

- 3/2/17 **ACDA** | Units 1-4 were southbound on Sawmill Parkway in the left lane approaching Village Club Dr. Units 2, 3, and 4 stopped for another accident. Unit 1 failed to stop and struck the rear of Unit 2 and pushed it into Units 3 and 4. Unit 1 was cited.
- 3/2/17 **ACDA** | Units 1 and 2 were traveling southbound on Sawmill Parkway in the left lane. Unit 2 slowed down near Village Club Dr. and Unit 1 was unable to slow down and struck the rear of Unit 2. Unit 1 was cited.
- 3/4/17 **Hit-Skip** | Unit 2 was parked in the lot at 8736 Moreland facing eastbound. An unknown unit, Unit 1, struck Unit 2 while unoccupied and fled the scene.
- 3/14/17 **Failure to Control** | Unit 1 was southbound on Thornbury Ln. at 37 Thornbury Ln. Unit 1 failed to use reasonable control, ran off the roadway to the right and struck a mailbox. Unit 1 was cited.
- 3/14/17 **ACDA** | Unit 1 failed to maintain an assured clear distance ahead and as a result struck Unit 2 from behind. Upon being struck by Unit 1, Unit 2 then was pushed into Unit 3. Upon this

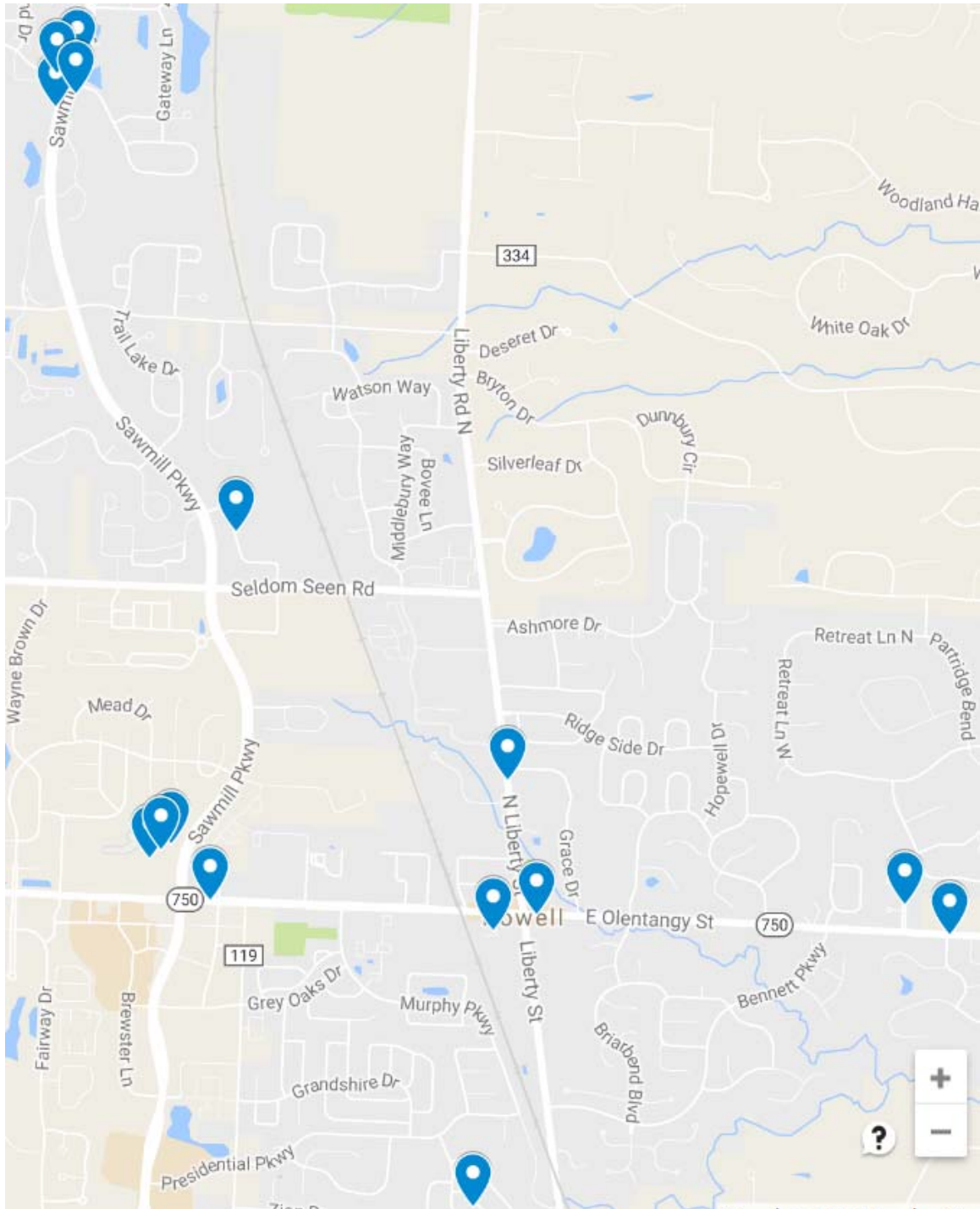
occurring, Unit 4 then struck Unit 1 from behind. At the time of the collision all units were heading south on Sawmill Pkwy.

- 3/18/17 **Hit-Skip** | The owner of Unit 2 came out of Giant Eagle to discover his car had been struck. A witness provided the license plate of the suspect vehicle that had struck Unit 2 and fled the scene. Unit 1 was cited.
- 3/20/17 **Hit-Skip** | Unit 2 was parked, unoccupied, in a parking lot located at 4000 W. Powell Rd. Unit 1 struck Unit 2 in an unknown manner and left the scene.
- 3/21/17 **ACDA** | Unit 1 failed to maintain an assured clear distance ahead when pulling into a parking spot located at the Giant Eagle shopping center. As a result, unit one struck Unit 2. At the time of the collision Unit 2 was parked and unoccupied.
- 3/23/17 **Hit-Skip** | Unit 2 was parked, unoccupied, at 240 N. Liberty St. in a parking space when it was struck in an unknown manner by Unit 1.
- 3/25/17 **Deer** | Unit 1 was eastbound on S.R. 750 when a deer passed in front of the vehicle from the south. Unit 1 struck the deer on the left front side of the vehicle.
- 3/27/17 **Hit-Skip** | Unit 2 was parked near 159 Timber Oak Dr on the road, when Unit 1 (unknown) struck it and fled the scene.
- 3/29/17 **Stop Sign** | Unit 1 was traveling northbound on Sycamore Ridge Dr and stopped at the stop sign for SR 750. Unit 2 was traveling westbound on SR 750. Unit 1 saw Unit 2 but thought the vehicle was already past him, so he proceeded through the intersection, striking Unit 2. Unit 1 was cited.
- 3/29/17 **Hit-Skip** | Unit 1 backed into unit 2. Unit 1 left the scene without making contact with the owner of Unit 2.
- 3/31/17 **Failure to Yield** | *Injuries* | Unit 2 was northbound on Sawmill Parkway. As he proceeded through the intersection with Village Club Drive, Unit 1 turned left into the path of Unit 2. Unit 2 was unable to stop and struck the passenger door of Unit 1. Unit 1 was cited.

3/31/17

Hit-Skip | Unit 2 was parked unoccupied in the lot of 47 Hall St. facing north. Unit 1 (unknown) struck Unit 2 and fled the scene.
