### PLEDGE OF ALLEGIANCE

#### CITIZEN PARTICIPATION

Vice Mayor Bennehoof opened the citizen participation session for items not included on the agenda.

Kelsey Fox, United Way of Delaware County. I wanted to share with you our Born Learning Trails, which is part of our strengthening families' initiative through United Way we are launching county-wide this summer. Our two goals are to increase social emotional skills for our children, birth to five. We are measuring that with the kindergarten-readiness assessment and we are measuring engagement for after school with our sixth, seventh and eighth graders through the Youth Risk Behavior Survey. We have both traditional and non-traditional partners, including our social service organizations as well as our local court system, law enforcement, all four school districts and career center.

Born Learning Trails are designed to create interaction between caregivers and children and they encourage conversation, looking at shapes, colors, numbers, and all of the senses. We have committed to doing 8 parks in the county this summer. Currently, all eight of our trails have been sponsored by local businesses, community members or families. [Ms. Fox showed an example of a sign that sponsors a trail]. We will be placing these signs in two of our parks. More information is available on United Way's website at liveunitedcentralohio.org. **RESOLUTION 2017-11:** A RESOLUTION AUTHORIZING PARTICIPATION IN THE ODOT WINTER CONTRACT (018-18) FOR ROAD SALT.

Mr. Lutz: This is a typical resolution being brought forward for the first time tonight and can be adopted tonight. This resolution authorizes us to utilize the Ohio Department of Transportation to bid our road salt for the 2017/2018 winter.
