Summary of Notable Revenue and Expenditure Items As of June 30, 2017

Revenue

- Municipal Income Tax: We have collected \$3,292,414.05 or 56.67% (through RITA) of our 2017 budget of \$5,809,472.00.
- Municipal Income Tax: Comparing 2017 municipal income tax collection to 2016 (year-to-date period) we are up 5.68%.
- Real Estate Taxes: We usually collect in two installments (March and August). We collected \$293,550.82 or 51.66%. Our 2017 budget was \$568,290.20.
- Development Fees: We have collected \$463,517.06 or 70.38% of our 2017 budget of \$658,584.00.
- Local Government Fund: We have collected \$81,236.23 or 45.84% of our 2017 budget of \$177,230.22.
- All Other General Fund Revenues: We have collected \$515,946.73 or 72.20% of our 2017 budget of \$714,634.12.
- Other Fund Revenues:
 - Parks & Recreation Programs Fund: We have collected \$160,496.50 or 97.27% of our 2017 budget of \$165,000.00 for Recreation; and we collected \$124,333.71 or 95.64% of our 2017 budget of \$130,000 for Powell Festival plus an additional \$39,729.05 in sales at Powell Festival.
 - Debt Service Funds: We have collected \$3,949,926.60 or 54.17% of our 2017 budget of \$7,291,751.41.
 - Downtown TIF: We collect in two installments (March and August). We collected \$147,159.79 or 49.43% of our 2017 budget of \$297,700.00.
 - Sawmill Corridor TIF: We collect in two installments (March and August). We collected \$154,961.04 or 66.65% of our 2017 budget of \$232,500.00.
 - Seldom Seen TIF: No collections have begun. However, we are collecting interest off the 1-year note of \$1,645.07.

Expenditures

Anticipated percentage range of expenditures is usually 48.0% to 56.0% for June.

- Administration – expenditures were \$144,587.88, which is 48.07% of their budget.
- Building – expenditures were \$315,207.39, which is 47.85% of their budget.
- Communications – expenditures were \$83,995.02, which is 45.17% of their budget.
- Council/Clerk – expenditures were \$120,836.43, which is 50.82% of their budget.
- Development – expenditures were \$146,689.99, which is 50.62% of their budget.
- Engineering – expenditures were \$184,034.98, which is 46.84% of their budget.
- Finance – expenditures were \$352,737.22, which is 38.48% of their budget.
- Information Technology – expenditures were \$157,844.75, which is 69.20% of their budget.
- Lands & Buildings – expenditures were \$80,529.48, which is 33.45% of their budget.

- Other Charges – expenditures were \$190,759.95, which is 53.10% of their budget.
- Park Maintenance – expenditures were \$248,318.19, which is 39.68% of their budget.
- Police – expenditures were \$1,458,211.12, which is 49.61% of their budget.
- Public Service – expenditures were \$323,285.92 which is 33.62% of their budget.
- Contingencies – as of June, we utilized \$0.00 -----leaving a balance of \$75,000.00.
- Other Funds:
 - Parks & Recreation Program Fund – expenditures are \$89,923.80 for recreation, which is 50.23% budget. The biggest sessions are the spring and summer. Expenditures are \$94,275.99 for Powell Festival, which is 84.55% of their budget.
 - Debt Service Funds – expenditures are \$3,526,674.42, which is 45.99% of their budget. Expenditures are usually seen in May (for June 1 due date) and November (for December 1 due date).

Other Items of Interest:

- ▶ The “Development” fees are what we look at to see if approximately 50% of the costs for the Building, Development and Engineering Departments are covered by the fees generated. It is estimated that approximately half of their work is related to city services and those services should be covered by resident taxes.

Development Fees and Expenditures through June are \$463,517.06 and \$647,761.66, respectively. Development Fees paid 71.55% of the costs.

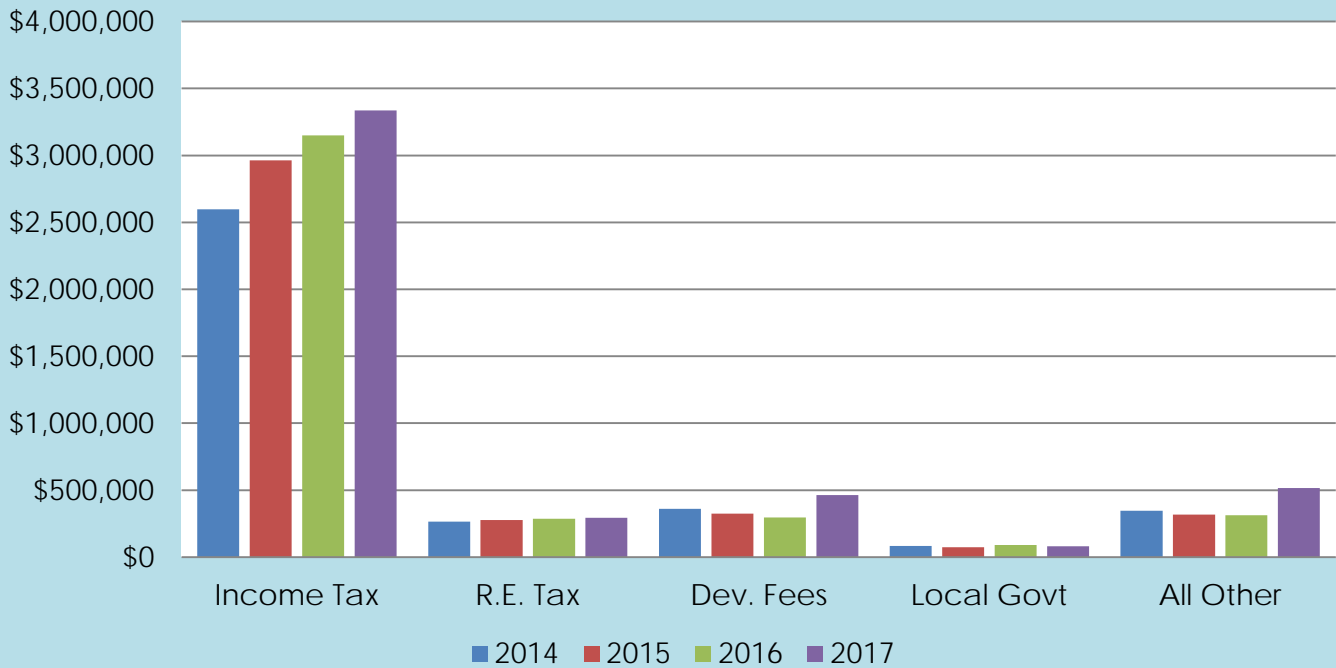
- ▶ The “Programming” revenues are what we look at to see if the Parks Programming is self-sufficient or close to being self-sufficient are direct costs.

Recreation Fees and Expenditures through June are \$160,496.50 and \$89,923.80, respectively. Recreation Fees paid 178.48% of the costs.
