NOTABLE CASES

Unlicensed Solicitor | Officers were dispatched to the Deer Run subdivision on a report of a solicitor offering to paint house numbers on the curb and asking for donations to OSU's medical school. He was cited for soliciting without a permit because he had been warned several times.

Forged Travelers Checks | A suspect passed forged travelers checks at a business on Sawmill Parkway. Powell Police identified the suspect as Anthony Sanders. The United States Marshals Service picked up the suspect and transported him to the Delaware County jail where he confessed to Powell Police Detective Smith. Mr. Sanders was on parole and faces charges for the same crime in locations around the country.



TRAINING



TRAFFIC CRASHES - PUBLIC & PRIVATE PROPERTY

- 10/2/17 **Failure to Yield** | Unit 2 was southbound on N. Liberty St. at Liberty Ridge Ave. Unit 1 was westbound on Liberty Ridge Ave. at N. Liberty St. When Unit 1 turned southbound onto N. Liberty, they failed to yield and struck Unit 2. Unit 1 was cited.
- 10/3/17 **Hit-Skip** | Unit 2 was parked in the Target parking lot from 1730-1910. During this time an unknown vehicle struck Unit 2 in the passenger side and left the scene.
- 10/5/17 **Hit-Skip** | Unit 1 struck a mailbox located on Ridge Side Drive in an unknown manner. Unit 1 left the scene without notifying the homeowner.
- 10/11/17 Failure to Yield | Unit 2 was traveling northbound on Sawmill Pkwy attempting to make a left turn onto Dolman Dr, when Unit 1 continued onto Sawmill Pkwy after stopping at a stop sign and struck Unit 2 on the passenger side front. Unit 1 stated they did not see Unit 2. Unit 1 was cited
- 10/13/17 **Hit-Skip** | Unit 1 was attempting to back out of a parking space at the business and struck the rear of Unit 2. The driver of Unit 1 left the scene without leaving proper documentation. Unit 1 was identified and cited.

- 10/14/17 **ACDA** | Units 1 and 2 were westbound on SR 750. Unit 2 slowed for traffic. Unit 1 failed to stop and struck Unit 2. Unit 1 was cited.
- 10/15/17 **OVI** | While traveling north on Sawmill Parkway, Unit 1 ran off the road to the right and struck the curb disabling the vehicle. Unit 1 was arrested.
- 10/18/17 **Red Light** | Unit 1 failed to yield to a traffic control device and as a result was struck by Unit 2. Unit 1 was heading westbound on SR 750 at the time of the collision and Unit 2 was heading south and exiting a private drive. Unit 1 was cited.
- 10/24/17 **Backing** | The driver of Unit 1 backed out of his driveway and struck Unit 2 causing property damage. Unit 2 was an unoccupied, parked motor vehicle. Unit 1 was cited.
- 10/26/17 **Hit-Skip** | Unit 1 was northbound on S. Liberty St. Unit 1 attempted to turn left onto SR 750 and the trailer left the roadway and struck a light pole. Unit 1 left the scene without reporting the crash.
- 10/26/17 **Hit-Skip** | Unit 2 was parked on the side of the roadway and Unit 1 struck it from behind. Unit 1 did not stop to report the crash and drove away from the scene. The driver turned herself in and received a citation for Hit-Skip and Failure to Control.


