Sex Offense | Two suspects have been indicted and arrested after they allegedly assaulted a juvenile at an underage drinking party in June 2017.



TRAINING

In January, the department conducted 60.5 hours of training to include LIFE Physical Fitness Class, Unmanned Aircraft Systems, and Legal Update Bulletins.

TRAFFIC CRASHES - PUBLIC & PRIVATE PROPERTY

- 1/2/18 **Hit-Skip** | Unit 1 struck Unit 2 which was parked and unoccupied. Unit 1 left the scene of the crash. Unit 2 was moved prior to the arrival of law enforcement.
- 1/3/18 ACDA | Unit 2 was stopped heading northbound in traffic, south of Presidential Parkway, on Sawmill Parkway. Unit 1 failed to maintain assured clear distance ahead and struck Unit 2 in the rear.
- 1/5/18 **Hit-Skip** | The owner of Unit 2 discovered his vehicle damaged while he was parked at 4002 W. Powell Road.
- 1/9/18 Failure to Control | Unit 1 was attempting to park next to Unit 2 (stationary) in the lot at 27 Clairedan Drive. Unit 1 slid on the ice and struck the driver-side rear quarter panel of Unit 2.

- 1/10/18 **Failure to Control** | Unit 1 was eastbound on Retreat Ln. west of SR 315. Unit 1 failed to maintain control of the vehicle, drove off the right side of the road, struck several bushes and an irrigation pipe.
- 1/15/18 Failure to Control | Unit 1 was northbound in the passing lane of Sawmill Parkway. Unit 1 was entering the driving lane of Sawmill Parkway when the vehicle lost traction and ran off the roadway. The vehicle struck a curb and then struck a street sign. Unit 1 re-entered the roadway and then again struck the curb before coming to a final rest in the snow.
- 1/16/18 **Hit-Skip** | Unit 2 was parked in a lot on Sawmill Parkway between 1450 and 2100 hours. During this time, an unknown vehicle struck the bumper of Unit 2.
- 1/18/18 Red Light | Unit 1 was attempting to turn right from the entrance of Giant Eagle to head south on Sawmill Parkway. While doing so, Unit 1 turned on red and struck Unit 2 that was southbound on Sawmill Parkway proceeding through the green light. Unit 1 was cited.
- 1/20/18 **Backing** | Unit 1 was attempting to back from a parking space at 484 W. Olentangy. The driver of Unit 1 did not see Unit 2 driving south in the lot and backed into Unit 2.
- 1/25/18 **Failure to Yield** | Unit 2 was westbound on SR 750. Unit 1 was exiting the lot of 195 W. Olentangy. Unit 1 pulled out from the driveway and struck Unit 2. Unit 1 was cited.
- 1/30/18 **Failure to Control** | Unit 2 was unoccupied and parked at 50 S. Liberty facing eastbound. Unit 1 pulled into a parking spot westbound, in front of Unit 2. Unit 1 failed to use reasonable control while parking and struck Unit 2 head on.
