The 44 Building Discussion David Betz presented the Board with the proposed License Addendum written by Law Director Gene Hollins with regard the exchange of furniture and furnishings being provided by Howard Hanna in exchange for the last month's rent (June 2018). Motion by David Betz to approve said addendum. Seconded by Don Emerick. Motion passed 5-Y; 0-N. Also discussed was the future tenancy of the building. Jim Hrivnak noted he will talk to a few people he knows who have expressed interest.

- **b.** Right-of-Way Conveyance for Economic Development Purposes per City Council Ordinance
  - David Betz explained the situation of the Case Avenue and Scioto Street leftover rights-of-way west of Depot Street, and how the City can convey these to the adjacent property owner for economic development purposes. City Council will be reviewing this at their next meeting and also the CIC would have to approve. Motion by Brian Lorenz to approve such conveyance pending City Council decision to do so and implement an agreement as recommended by the City Law Director. The motion was seconded by Mike Linehan. Motion approved: 5-Y; 0-N.
