


In February the department conducted 27 hours of training to include **Body Worn Cameras**, **Intelligence Liaison Annual Conference**, and **PELC Retrainer**.

TRAFFIC CRASHES – PUBLIC & PRIVATE PROPERTY

- Hit-Skip | Unit 2 was parked on the side of the road near
 4111 Village Club Dr. Sometime between 1/31/18 and
 2/2/18 at 1500, the vehicle was struck on the left rear
 quarter panel by an unknown vehicle.
- 2/8/18 **Failure to Control** | Unit 2 was parked and unoccupied. Unit 1 struck Unit 2 while entering the adjacent parking spot. Driver of Unit 1 was unaware she struck Unit 2.
- 2/8/18 **Backing** | Unit 1 was attempting to back out of a parking stall at 4000 W. Powell Rd. Unit 2 was driving through the lot. Unit 1 backed into Unit 2.
- 2/21/18 **Hit-Skip** | Unit 1 struck a sign pole in the area of Grace Dr and SR 750 from an unknown direction. Unit 1 left the scene without reporting the crash.
- 2/21/18 **Failure to Yield** | While turning right to go north behind a white truck, Unit 2 struck Unit 1 that was turning left to go northbound on Sawmill Pkwy. Due to conflicting statements the at-fault party cannot be determined.
- 2/23/18 **Failure to Control** | Unit 1 was westbound on Ridge Side Dr. and Units 2, 3, and 4 were parked along the roadway facing westbound. Unit 1 struck Unit 2 in the rear and pushed it into Unit 3 and Unit 4.
- 2/26/18 **Hit-Skip** | Unit 1 was struck by an unknown vehicle while parked at 4000 W. Powell Road.

- 2/27/18 **Failure to Yield** | Unit 1 was heading westbound in the parking lot of 3976 W. Powell Rd when it struck a pedestrian, Unit 2, who was walking in the parking lot.
- 2/27/18 Failure to Yield | Unit 1 and Unit 2 were on the private access road of Giant Eagle at 4000 W. Powell Rd. Unit 2 had stopped at a stop sign traveling west and began turning southbound. Unit 1 had stopped at the same intersection stop sign, traveling east. Unit 1 failed to yield before turning southbound, and struck Unit 2.
- 2/27/18 **Red Light** | Unit 1 failed to obey a traffic control device, and entered the intersection of Presidential Pkwy and Sawmill Pkwy traveling westbound to execute a left turn. Upon entering the intersection improperly, Unit 1 was struck by Unit 2 which was heading northbound on Sawmill Pkwy. Unit 1 was cited.


MAP OF TRAFFIC CRASHES
