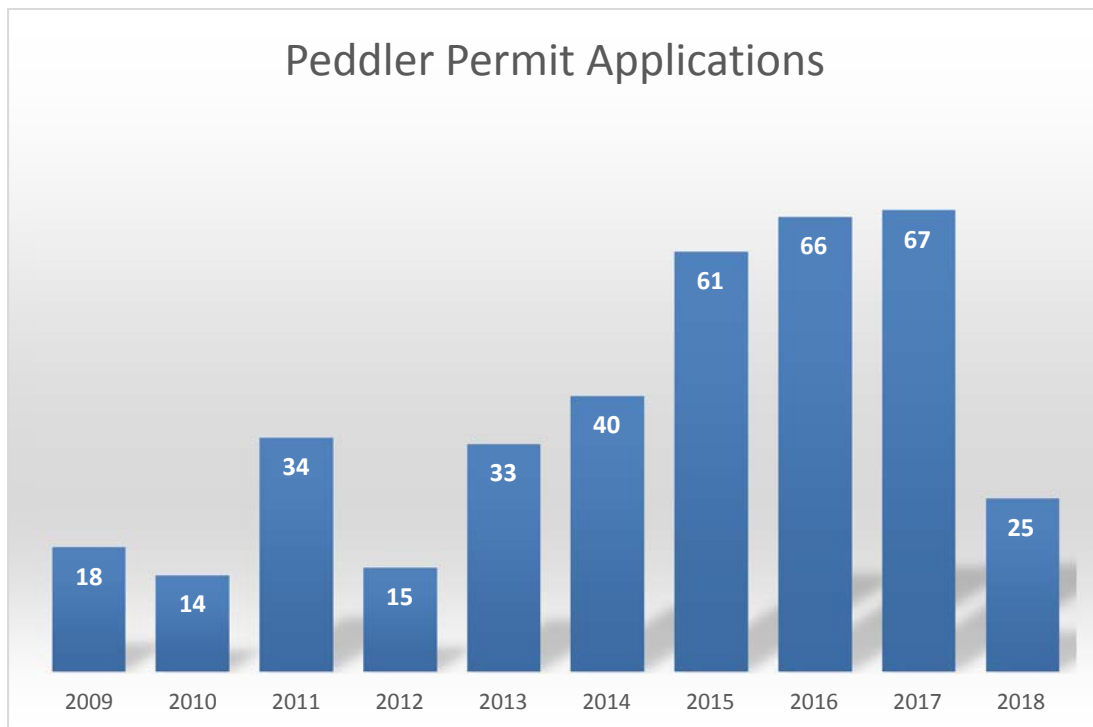

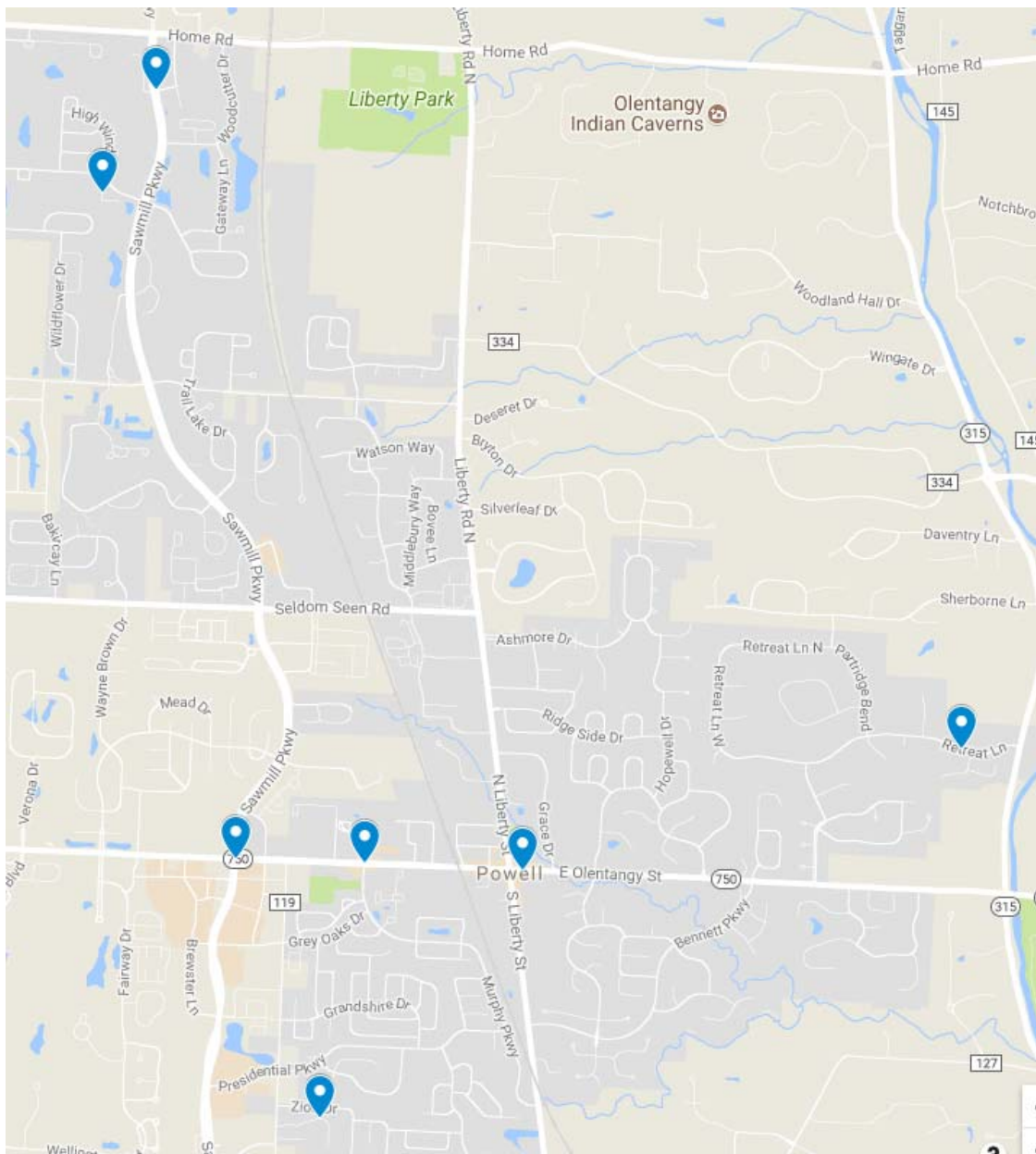
TRAFFIC CRASHES

- 3/6/18 **Backing** | Units 1 and 2 were parked heading east on Commons Drive. Driver of Unit 1 entered his vehicle and began backing up and struck Unit 2.
- 3/9/18 **Hit-Skip** | The listed accident witness advised that an unknown vehicle left the roadway in front of his home and struck his mailbox. The driver was identified and cited.
- 3/12/18 **Failure to Control** | Unit 1 was slowly heading east through in the parking lot of 15 E. Olentangy Street with an obstructed windshield (ice) when it struck the left side of Unit 2 which was unoccupied.
- 3/15/18 **ACDA** | Unit 1 stated she "zoned out" while driving northbound on Sawmill Parkway as she was approaching the intersection of O'Connell. She struck Unit 2 which was stopped at a red traffic signal at the intersection. Unit 2 then was pushed into Unit 3. Unit 1 was cited.
- 3/18/18 **Failure to Yield** | Units 1 and 2 were traveling on SR 750, approaching Sawmill Parkway in opposite directions. Unit 1 made a left turn onto Sawmill Parkway on a yellow traffic light and was struck by Unit 2.
- 3/22/18 **Backing** | Units 1 and 2 were both backing out of parking spots in Kinsale Golf Club. Unit 1 stated he came to a stop, and Unit 2 backed into him. Unit 2 stated they both were backing at the time of the crash. Due to conflicting statements and no witnesses, the at-fault party cannot be determined.
- 3/30/18 **Failure to Control** | Units 1 and 2 were eastbound on SR750 just West of Murphy Parkway. Both units stopped for the light/traffic at the location. The driver of Unit 1 attempted to reach down for an item which caused his foot to slip off the brake, and Unit 1 struck Unit 2. Unit 1 was cited.

TRAINING

In March the department conducted 40 hours of training to include **Glock Armorer, pistol qualification, and firearms training.**
