| ✓ Generator manufacturer's specifications including model ,installation guidelines and gas requirements.  |                 |
| ✓ Electrical one line diagram to include transfer method/equipment, conductor types and sizes, load/circuits to be transferred and load management.   |                 |
| ✓ Detail of required signage (NEC 702.7)  |                 |
| ✓ Gas piping types, sizes, lengths, valves and regulators. Include gas usage for existing appliances as well or approval from the gas purveyor verifying gas service is adequate to provide for the additional load.      |                 |

Plan reviews will be done in the order they are received with all efforts for prompt review. You will be notified of any corrections/revisions required for further review or that your approved plans and permit are ready to be picked up.

**Permit Fees** - Fees are collected when the permit has been approved and is ready to be picked up

	Electric	\$200.00
	Fuel Gas Line	\$100.00 (includes up to 2 appliances)
Zoning fees:	Zoning Certificate	\$ 25.00

3% State of Ohio surcharge will be added to all commercial building permit fees

**Inspections** Gas piping - prior to cover and final  
Electric - underground, rough and final  
Inspector to witness generator start up and operation and final
