



INDUSTRIALIZED UNIT PERMIT – CITY OF POWELL COMMERCIAL (Construction Trailer/Sales Trailer)

PERMIT REQUIREMENTS

- ✓ Industrialized Unit permit application
 - ✓ Plot Plan – show placement of trailer on lot or job site
 - ✓ Detailed drawing showing
 - a. Length & width of unit
 - b. Number of piers and their spacing – per side
 - c. Number of tie downs and their spacing – per side
 - d. Type of anchor (cross drive type usually not applicable)
- Pier pads are required for temporary installations
Piers should be spaced no greater than 10 feet
Manufacturer's specs govern
