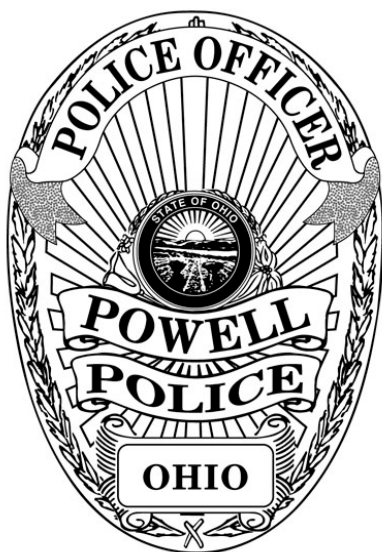

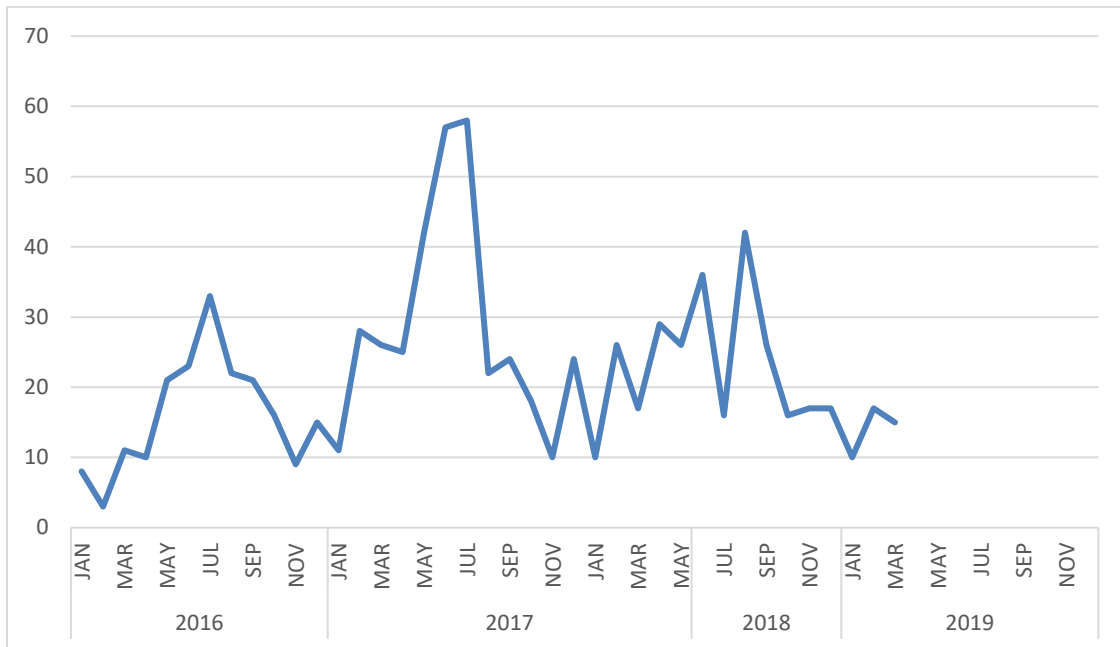
Stolen Firearm | A resident of Golf Village returned from vacation to find his firearm missing. Several people were in the house in his absence. The case is under investigation.

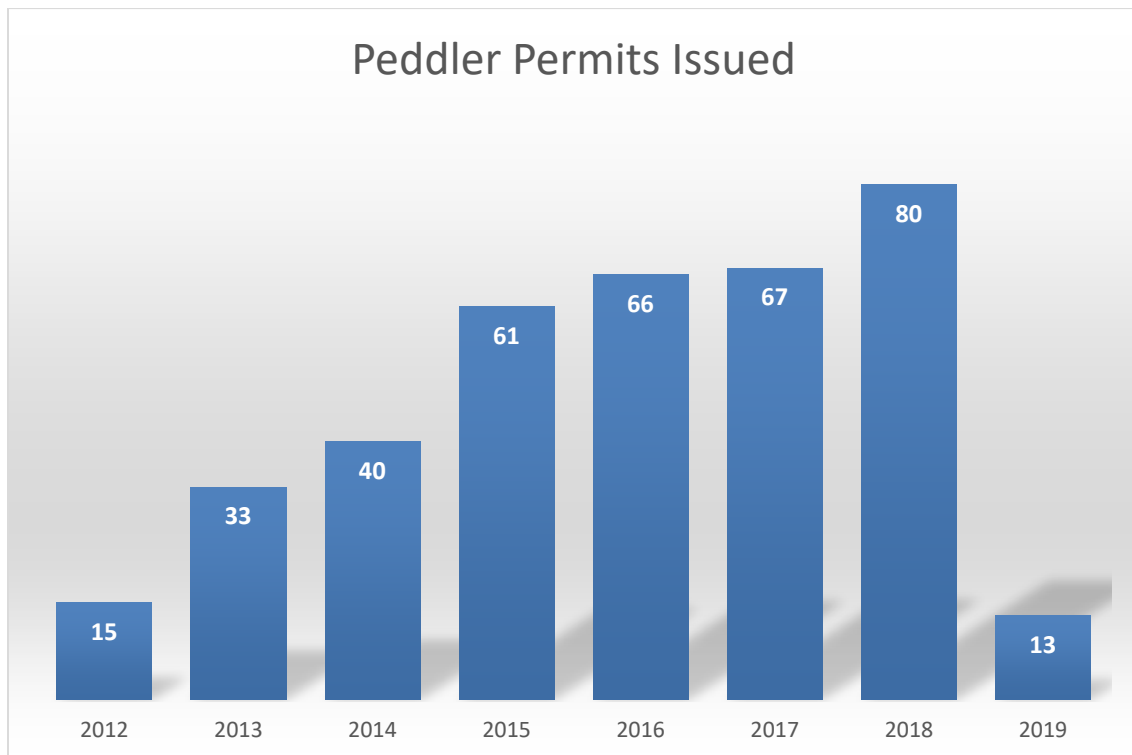

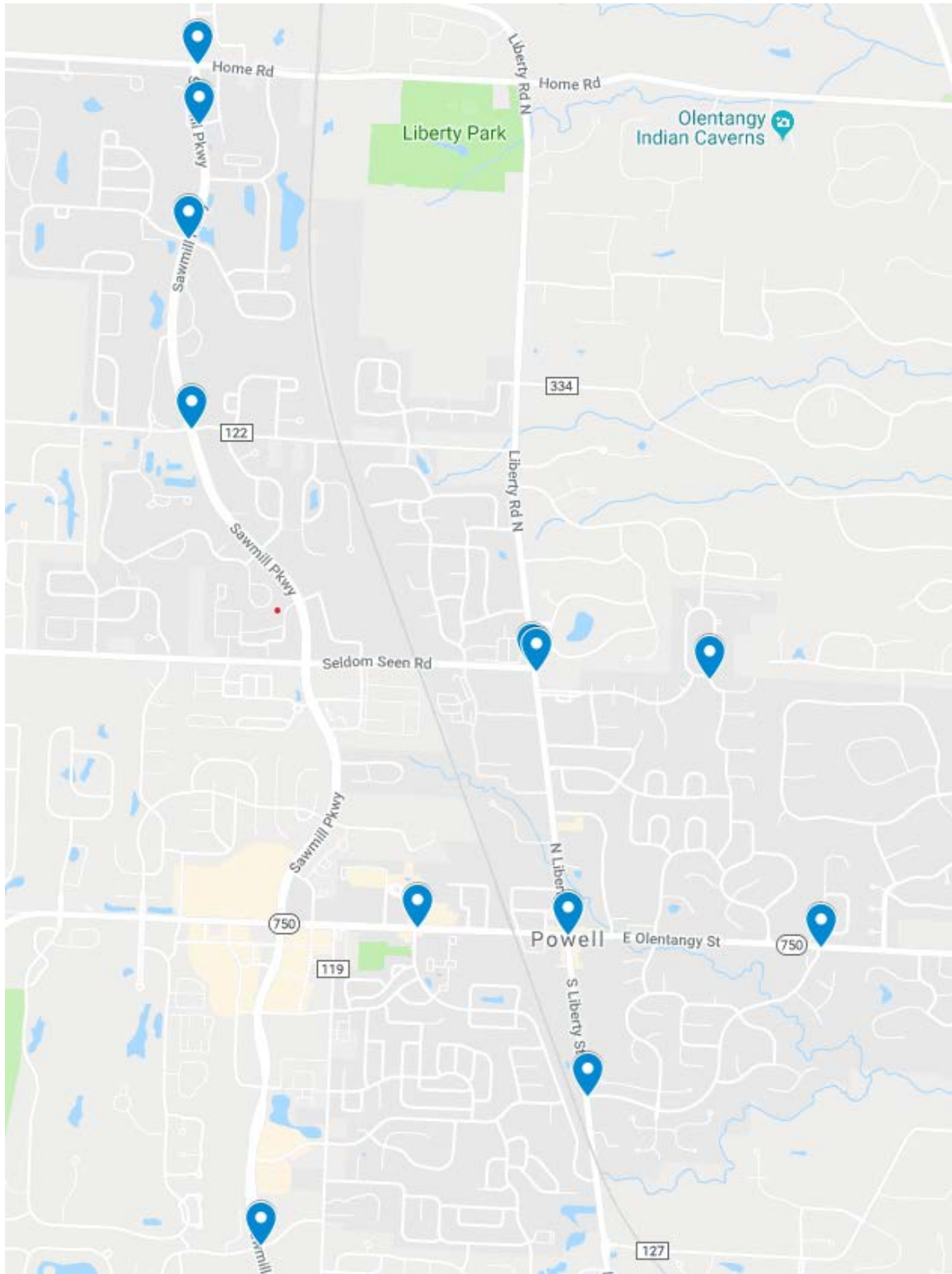

TRAFFIC CRASHES

DATE	CAUSE	NARRATIVE
3/8/19	Marked Lanes	Unit 1 was in the eastbound left turn lane of O'Connell St. at Sawmill Pkwy. Unit 2 was eastbound on O'Connell St. Unit 1 attempted to merge into the right turn lane and made contact with Unit 2. Unit 1 was cited.
3/9/19	ACDA	<i>Injury</i> Unit 1 and 2 were westbound on SR750 just west of Murphy Parkway. Unit 2 stopped for traffic. The driver of Unit 1 attempted to stop but her foot came off the brake, and she struck Unit 2. The driver of Unit 2 indicated that she was feeling lower back pain. Unit 1 was cited.
3/12/19	Fail to Control	The driver of Unit 1 was heading northbound on Liberty Road and became distracted. Unit 1 then veered left of center and drove off the roadway, striking a speed limit sign before his vehicle became stuck in the mud and stopped. Unit 1 was cited.
3/12/19	Fail to Yield	<i>Injury</i> Unit 2 was northbound on Sawmill Pkwy. at Home Rd. and Unit 1 was southbound on Sawmill Pkwy. approaching Home Rd. Unit 1 attempted to turn left onto Home Rd. and struck Unit 2. Unit 1 was cited.
3/14/19	ACDA	Unit 1 and Unit 2 were northbound on Sawmill Parkway at Village Club Drive. Unit 2 stopped for traffic and Unit 1, unable to stop struck the rear of Unit 2. Unit 1 was cited.
3/17/19	OVI	Unit 1 was traveling N/B on Nathan Dr. when he left the roadway and traveled through the yard of 367 Nathan Dr. He then struck a vehicle in the driveway of 357 Nathan Dr. causing his vehicle to flip on its side. The vehicle came to rest in the front yard of 357 Nathan Dr. alongside the garage of the residence. Unit 1 was cited.
3/17/19	Fail to Yield	<i>Injury</i> While attempting a left turn from Seldom Seen Road to North Liberty Road, Unit 1 was struck in the driver side by Unit 2, who was traveling south on Liberty Road.
3/18/19	Marked Lanes	Unit 1 was westbound on Rutherford Rd. at Sawmill Pkwy. Unit 2 was eastbound on Rutherford Rd. at Sawmill Pkwy. Unit 2 preceded to turn onto Sawmill Pkwy. northbound and was in the left (west lane). Unit 1 turned right onto Sawmill Pkwy. and struck Unit 2. Unit 1 was cited.
3/21/19	ACDA	Units 1 and 2 were southbound on N. Liberty St. north of SR 750. Unit 2 was stopped in traffic. Unit 1 started to pull forward and struck Unit 2. Unit 1 was cited.

DATE	CAUSE	NARRATIVE
3/19/19	Fail to Yield	While attempting a left turn from Bennett Parkway to South Liberty Street, Unit 1 struck the driver side of Unit 2 who was traveling southbound. Unit 1 was cited.
3/26/19	ACDA	Units 1 and 2 were eastbound on N. Hampton Dr. west of Sawmill Pkwy. Unit 2 stopped for the traffic signal. Unit 1 pulled forward and struck Unit 2. Unit 1 was cited.
3/26/19	ACDA	Three units were westbound on SR 750 just east of Bennett Parkway. Unit 3 stopped for traffic and Unit 2, unable to stop, struck Unit 3. Unit 1 then struck Unit 2. Units 1 and 2 were cited.
