HIGHLIGHTS

- The Engine/Rescue committee visited Sutphen to look at the progress of the new vehicle. Sutphen is now reporting a June delivery. The committee was very happy with the progress so far.
- We are working with the Parks/Roads and local park officials to establish a marking system for the trails that will allow for anyone who may need help to pinpoint their location better. If the plan and system are successful, it may be rolled out county wide.
- Re-started the review of the Strategic Plan and Capital review. Now that contract negotiations are finalized, the budget forecast will allow for reviewing and implementing service improves for EMS/ Fire response. Major purchase that will be considered are a new aerial device, the need for a 3rd station, staffing and succession planning.
- Dr. Panchal has brought several ideas and ground breaking treatments to us for potential implementation. The need to re-visit Community Paramedicine and an attempt to re-partner with Source pint has also been discussed.
- Received a letter regarding our deployment to North Carolina during the hurricane last year, along with notification of reimbursement payment.
- The letter is attached at the end of this report.
