TRAINING


In April the department conducted 76 hours of training to include **Ohio Crime Prevention Conference**, **Firearms**, **Defensive Tactics** and **First Aid**.



DATE	CAUSE	NARRATIVE
4/1/19	Failure to Yield	Injury Unit 1 was traveling eastbound on Attucks Drive, Unit 1 failed to yield and was struck in the side by Unit 2, who was traveling northbound on Sawmill Road. Unit 1 was cited.
4/7/19	Failure to Yield	Injury Unit 1 came to a stop at the intersection of Stoneway Point and Sawmill Pkwy. Unit 1 then moved forward, striking Unit 2 (bicycle). Unit 2 was on a bike path and had legally entered the roadway before being struck. Unit 1 was cited.
4/9/19	ACDA	Unit 2 was stopped in traffic northbound on S. Liberty St. at SR 750. Unit 1 was also northbound, behind Unit 2 in traffic. Unit 1 failed to use assured clear distance ahead and struck Unit 2. Unit 1 was cited.
4/10/19	Hit-Skip	Unit 1 was westbound on S.R. 750 in the area of 60 E. Olentangy St, when it went off the right side of the road and struck two mailboxes with the front passenger side of the vehicle. Unit 1 then left area without reporting the crash.
4/10/19	ACDA	While slowing for traffic, Unit 2 was struck in the rear by Unit 1. Both units were traveling westbound on SR 750 (W. Olentangy Street.) Unit 1 was cited.

My service dog TREX Rufus "Rufus" and I appreciate your assistance getting us back to my vehicle safely, after our adventures at Adventure Park, Jeni's Splendid Ice Cream, and The Village Green Park.

- * Normally, I'm capable navigating back to our vehicle after our adventures in Powell, safely. We typically visit Powell once or biweekly for an appointment, then after our appointment, I reward myself a cup of Jeni's Splendid Ice Cream.
- * We walk from our appointment to Jeni's if weather permitted. Today, was a lovely perfect weather besides the gusty wind condition.

I inform my friend where I'm going that day too, so just in case something happens and she doesn't worry, too. As well, if I'm unable to communicate verbally.

* Today, was a different chaotic adventure as the sidewalks are closed downtown Powell, due to the City is installing accessible ramps (Yay!).

I'm inclined to get unequivocally discombobulated if things are altered or the routine path I take are under construction. It throws my neurons into a loop of blackhole state of a swirling meltdown.

- * I have difficulties crossing streets and the traffic scares me when I'm in a state of swirling meltdown.
- * I'm not the greatest asking for help, due to fear of being judged negatively. However, today I asked for an assistant at the Powell Police Department. I wasn't judged negatively or felt I was interrupting their important work to assist my service dog and me.

I spoke to two wonderful women at the main receptionist desk, which I explained to them my situation and asked for assistance. They were extremely cordial, patience, and helpful, which they didn't make me feel bad for asking for assistance crossing a street to go back to my vehicle.

Officer Sanford spoke to me and explained the two options: He could assist me in crossing the street or ride in his Police cruiser with my service dog. He spoke to me as an individual with dignity. Officer Sanford never made an impression I was taking his time away from his duties to assist me.

- * I have never been in the back seat of a Police cruiser before, which is good! If you don't want to be back in the cruiser, follow the law or the law will come after you!
- * The back seat is rather nice, though not for the bad guys. I'm rarely in the back seat as you know you can't drive seating in the back seat yet. In addition, I don't trust my service dog to drive me, he be looking for chickens crossing the streets.

Officer Sanford is/was remarkably patient with my service dog and I as he le me talk his ears off. I talk fast when I'm in my panic state and repeats myself over and over. He told me it was okay for me to talk.

* He helped carry my "100lbs" of "Entire Bag of Life" too. It's heavy, though I'm used to it. I told him it



was heavy

Thanm you for providing an exceptional service to my service dog and I today, my without fear of taking time away from your duties or being judged negatively.

I appreciate your acceptance of me as an Autistic and my service dog as a service dog. The respect is greatly honorable.


