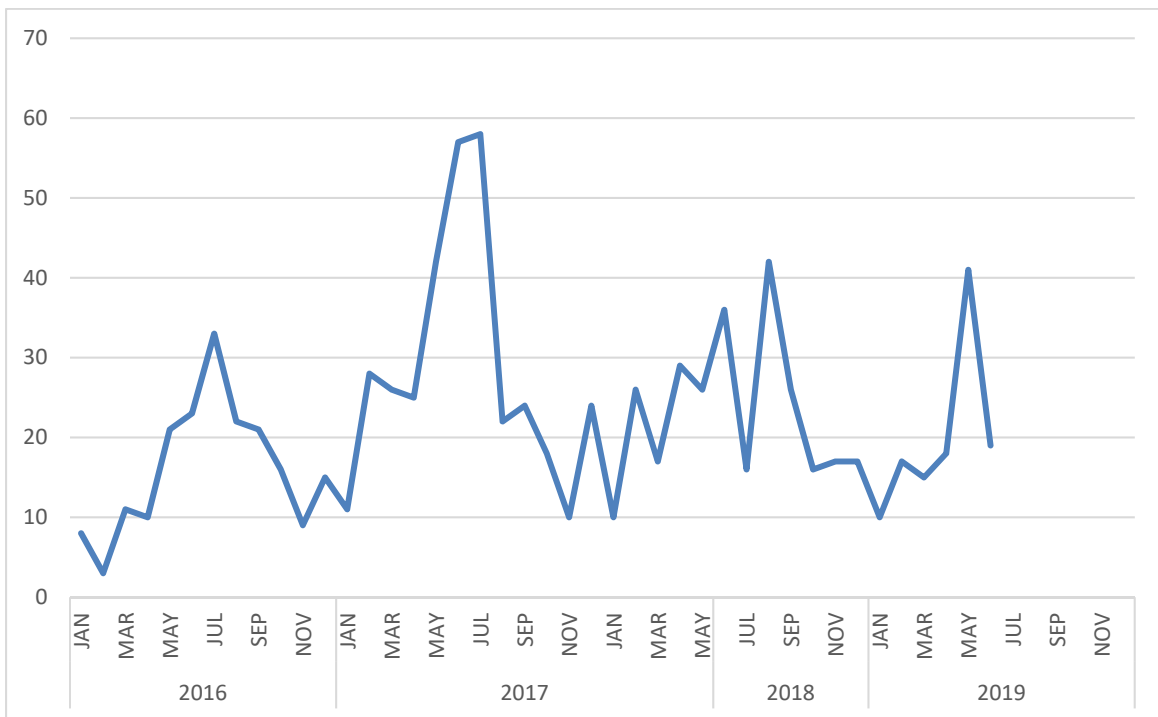

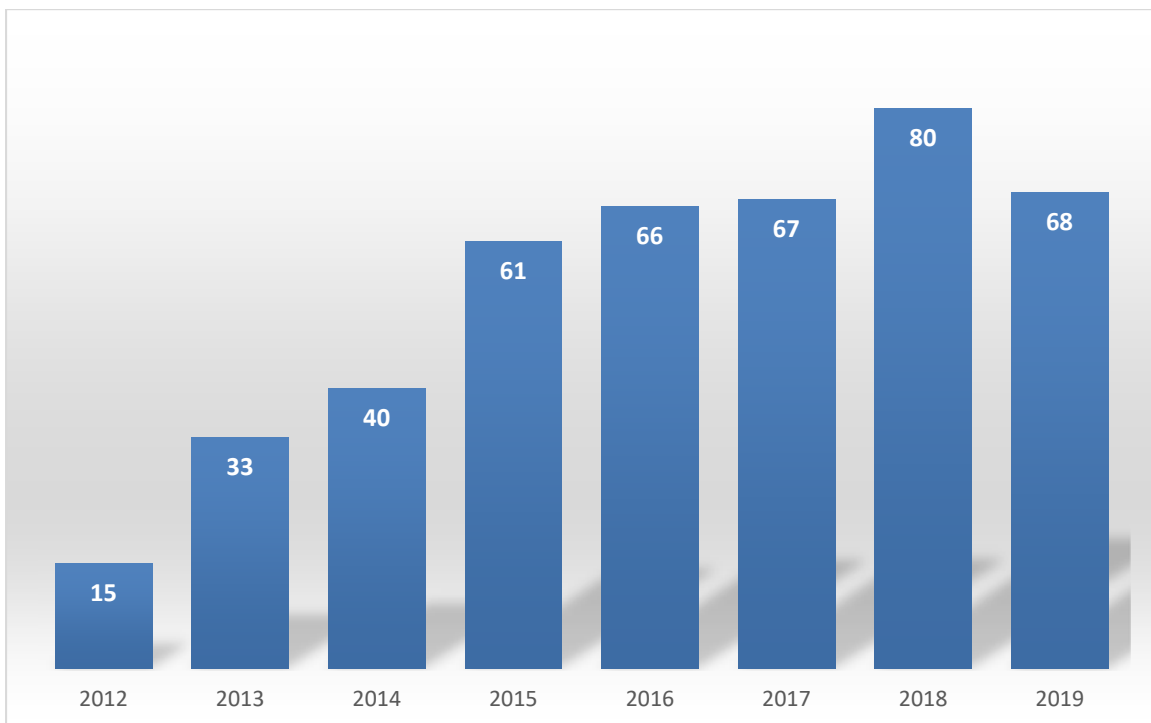

TRAFFIC SURVEYS (STEALTH STAT)

The City of Powell Police Department uses this data to assign officers for selective enforcement efforts.

Average Speed: The average speed of all vehicles registered by the StealthStat device.

85th Percentile: 85 percent of all vehicles were at this speed or slower.

Vehicles per Hour: On busy streets, the device cannot accurately count vehicles in the far lane.

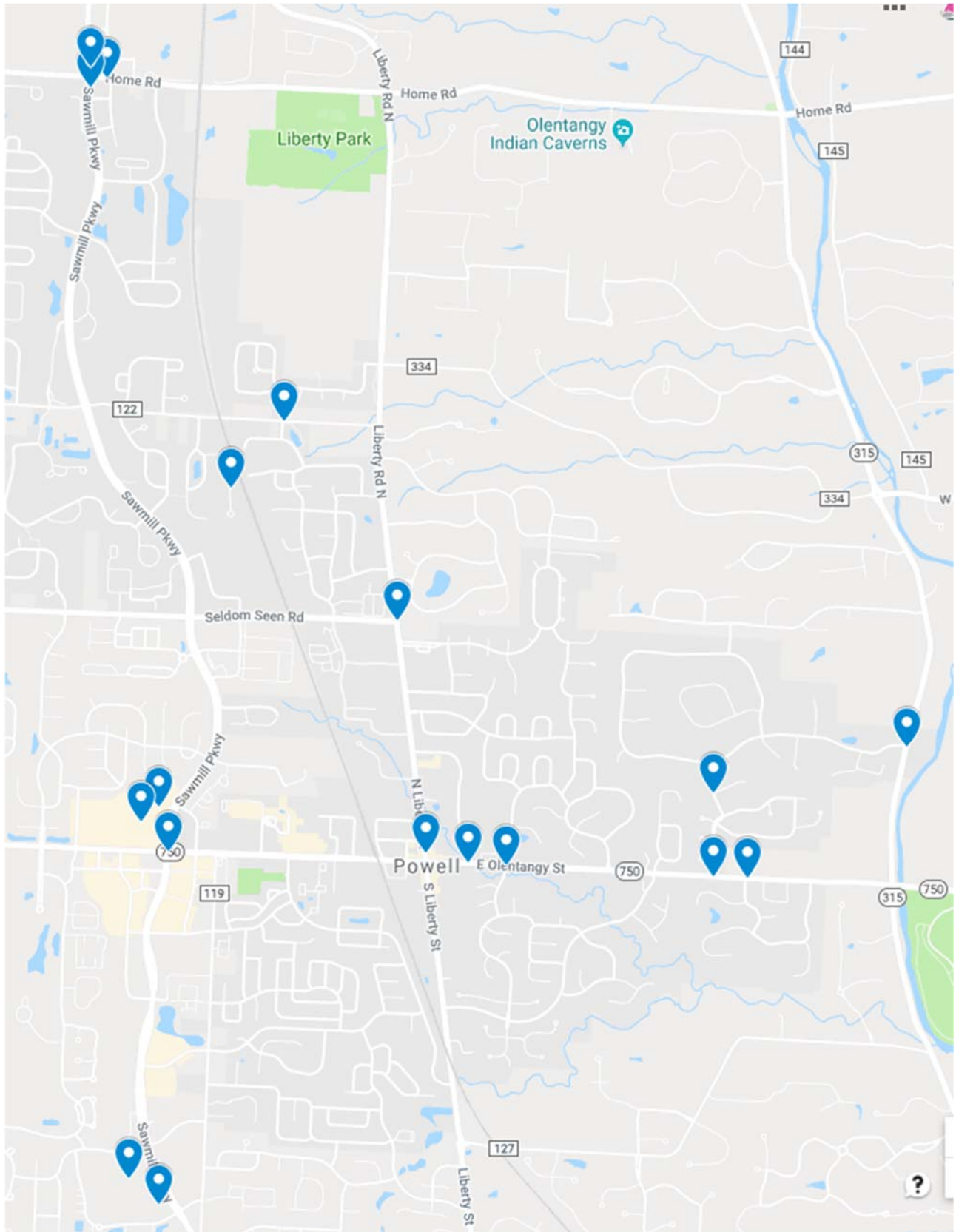

TRAFFIC CRASHES

DATE	CAUSE	NARRATIVE
6/1/19	Fail to Yield	Unit 2 was westbound on SR 750 when Unit 1 attempted to turn left from Sycamore Ridge Dr. and SR 750 and struck Unit 2 in the right side after failing to yield at a stop sign. Unit 1 was cited.
6/6/19	Hit-Skip	Unit 2 was parked in a parking spot at 3982 W. Powell Rd. An unidentified vehicle struck Unit 2 and fled the scene.
6/7/19	ACDA	<i>Injury</i> Unit 2 was stopped on Raccoon Run just north of Eagle Ridge facing northbound. Unit 1 was northbound on Raccoon Run and did not realize Unit 2 was stopped and rear-ended Unit 2. Unit 1 was cited.
6/8/19	Control	Unit 1 was northbound on N. Liberty St. approaching Seldom Seen Rd. Unit 1 attempted to turn left onto Seldom Seen Rd., when the driver lost control the vehicle, drove off the right side of the road, struck a traffic sign and a metal support cable before stopping on Seldom Seen Rd. Unit 1 was cited.
6/9/19	OVI	Unit 1 was traveling westbound on Rutherford Road, when it drove left of center and off the left side of the roadway. Unit 1 then drove into a drainage ditch after leaving the roadway. Unit 1 was cited.
6/10/19	Hit-Skip	Unit 2 was parked in a parking space at 10560 Sawmill Pkwy. when Unit 1 attempted to turn into a parking space next to Unit 2. Unit 1 struck the left rear corner of Unit 2 with the right front corner of Unit 1, then drove away without reporting the crash.
6/12/19	Hit-Skip	While parked at 22 North Liberty Street, Unit 2 was struck in the rear bumper by Unit 1. Unit 1 was backing from a parking spot north of Unit 2. After striking Unit 2, the driver of Unit 1 exited their vehicle, looked at the damage on Unit 2 and left the scene on N. Liberty Street.
6/13/19	Fail to Control	Unit 2 was parked in a parking space at 4000 W. Powell Rd. Unit 1 pulled into a parking space next to Unit 2 and sideswiped the driver's side of Unit 2.
6/18/19	Backing	Unit 2 was parked in front of 8548 Maple Leaf Ct., unoccupied and facing south. Unit 1 backed from the driveway of 8541 Maple Leaf Ct., westbound, and struck Unit 2.

DATE	CAUSE	NARRATIVE
6/20/19	ACDA	Units 1 and 2 were northbound on SR 315 at Retreat Ln. Unit 2 started to brake due to other vehicles stopping due to deer crossing the roadway. Unit 1 was unable to stop and struck Unit 2. Unit 1 was cited.
6/21/19	ACDA	Unit 2 was stopped at the red light waiting to make a right turn to head west onto SR 750 from Grace Drive. Unit 1 rear-ended Unit 2. Unit 1 was cited.
6/22/19	ACDA	Unit 1 and Unit 2 were traveling west on E. Olentangy St. near the cross street of Beech Ridge Dr. when Unit 1 struck Unit 2 in the rear of the vehicle. Unit 1 was cited.
6/22/19	Marked Lanes	Unit 1 failed to stay within marked lanes and as a result sideswiped Unit 2 on Sawmill Pkwy. Both units were traveling south at the time of the collision.
6/22/19	Fail to Yield	Unit 1 failed to yield to oncoming traffic while executing a left turn from Sawmill Pkwy. to Home Rd. Unit 1 struck Unit 2 which was traveling southbound at the time of the collision. Unit 1 was cited.
6/25/19	Marked Lanes	Unit 1 and Unit 2 were both traveling northbound on Sawmill Pkwy. Unit 1 stated Unit 2 performed an improper lane change and struck him while trying to change lanes. Unit 2 stated both he and Unit 1 were already in the lane of travel and Unit 1 failed to keep assured clear distance ahead and struck him in the rear. Due to the conflicting statements and no witnesses the at fault party cannot be determined.
6/26/19	Inattention	Unit 1 and Unit 2 were proceeding through a car wash at 10688 Sawmill Pkwy. Unit 1 failed to put his vehicle into neutral while on the belt and struck the rear of Unit 2 in the car wash.
6/26/19	Fail to Yield	<i>Injury</i> Unit 1 was westbound and Unit 2 was eastbound on Home Road approaching the intersection of Sawmill Pkwy. Unit 1 made a left turn and struck Unit 2 in the driver's side. Unit 1 was cited.
6/26/19	ACDA	Units 1 and 2 were eastbound on SR 750. Unit 2 stopped in traffic at Thornbury Ln. and was struck in the rear by Unit 1. Unit 1 was cited.
