STATISTICS

Note: In 2019, the Dispatched Calls calculation counts Traffic Control as officer-initiated calls. *Traffic stops and citations were high in October due to focused enforcement of prohibited left turns at the four-corners intersection.

NOTABLE CASES

Left Turns | The new hours for restricted left turns at the four corners (7 a.m. to 7 p.m.) went into effect in early October. Police allowed drivers to acclimate to the change for a period; warned drivers for another period; observed traffic next; and finally wrote citations from October 28 to November 3.


Over 335 warnings and 58 citations were issued for prohibited left turns at that intersection.



TRAINING

In October the department conducted 254 hours of training to include CPR, Firearms, Close Quarters Battle, Simunitions, Public Records, Taser Instructor and The Great Lakes Leadership Seminar.

TRAFFIC SURVEYS (STEALTH STAT)

The City of Powell Police Department uses this data to assign officers for selective enforcement efforts.

Vehicles per Hour: On busy streets, the device cannot accurately count vehicles in the far lane.
Average Speed: The average speed of all vehicles registered by the StealthStat device.
85th Percentile: 85 percent of all vehicles were at this speed or slower.
Ten-Mile Pace: The range of speeds in which the majority of vehicles were traveling.




TRAFFIC CRASHES

DATE	CAUSE	NARRATIVE
10/3/19	Mech- anical	While turning onto N. Liberty St. from Brookehill Dr., Unit 1's equipment on its truck's bed struck wires from the electrical pole, causing the wires to fall and become damaged.
10/3/19	Backing	Unit 1 improperly backed and struck Unit 2 while attempting to turn around on Lincoln St. Unit 2 was unoccupied and parked on Lincoln St. on the side of the roadway. Unit 1 was cited.
10/5/19	Backing	Unit 2 was legally parked on the street, when Unit 1 backed from the driveway of 320 Ashmoore Circle West. Unit 1 struck the driver's side front door of Unit 2 with the rear of Unit 1.
10/9/19	Control	Unit 2 was parked on the street at 206 Watson Way facing westbound. Unit 1 was westbound on Watson Way failed to control their vehicle and side-swiped Unit 2. Unit 1 was cited.
10/10/19	Stop Sign	Unit 2 was traveling westbound on Ashmoore Drive, as Unit 2 made a left turn from Bettendorf Circle. Unit 1 failed to yield at the stop sign and struck Unit 2 on the driver's side. Unit 1 was cited.

DATE	CAUSE	NARRATIVE	
10/11/19	ACDA	Unit 2 was traveling eastbound on SR 750 when it slowed with traffic preparing to turn north onto Olentangy Ridge Place. Unit 1 (unknown) failed to stop in time and rear ended Unit 2 then fled the scene. Unit 2 sustained minor property damage.	
10/12/19	Backing	Unit 2 was parked in the grass near 18 Grace Dr. and Unit 1 was parked near Unit 2. Unit 1 attempted to back, struck Unit 2, and left the scene. Unit 1 was cited.	
10/12/19	Yield	Unit 1 was northbound and Unit 2 was southbound on Sawmill Pkwy. Unit 1 made a left turn into the path of Unit 2 causing Unit 2 to crash into Unit 1. Unit 1 was cited.	
10/14/19	ACDA	Units 1 and 2 were westbound on W. Olentangy St. (SR 750). At 27 W. Olentangy St., Unit 2 slowed for traffic and was struck in the rear by Unit 1. Unit 1 was cited.	
10/17/19	Yield	Unit 2 was westbound on N. Hampton Dr. and Unit 1 was eastbound on N. Hampton Dr. Unit 1 attempted to turn left onto Sawmill Pkwy and struck Unit 2 in the intersection. Unit 1 was cited.	
10/24/19	Control	Unit 1 and Unit 2 were advancing from a stopped position on Sawmill Parkway and North Hampton. The driver of Unit 1 looked over her left shoulder in an attempt to switch lanes and drifted out of her lane, striking Unit 2. Unit 1 was cited.	
10/29/19	Stop Sign	<i>Injury</i> Unit 2 was southbound on Liberty Rd. Unit 1 was attempting to enter Liberty Rd. from Bryton Dr. Unit 1 pulled across Liberty Rd. and was struck in the southbound lane by Unit 2. Unit 1 was cited.
