

COMMUNITY ENGAGEMENT



It was Child Passenger Safety Week September 20-26. Officer A. Wilt attended a virtual conference hosted by University Hospitals on Child Passenger Safety and installed nine car seats last month! She also promoted Child Passenger Safety Week on Facebook.

DRONE PROGRAM

In September, the Mavic Mini drone was deployed to assist the Delaware County Sheriff's Office with a barricaded female suspect in Delaware City. The same drone was used in September to prepare a tour of the police station for our virtual on-site CALEA assessment in October. •

TRAINING



In September the department conducted 159.5 hours of training to include **Property Room Management, Firearms, Defensive Tactics, Use of Force, Animal Encounters, Street Smart Drug Series** and **Ethics and Professionalism**.

In addition, **Officers Cook** and **A. Wilt** attended collaborative training for the Delaware Tactical Unit (DTU) and the Crisis Negotiation Team (CNT). This was scenario training where the teams worked together.

USE OF FORCE

The Powell Police Department carefully tracks all uses of force by the agency. In the interest of transparency, we will report these incidents monthly. There were no uses of force in September. •

TRAFFIC SURVEY (STEALTH STAT)

The City of Powell Police Department uses this data to assign officers for selective enforcement efforts.

Average Speed: The average speed of all vehicles registered by the StealthStat device.
85th Percentile: 85 percent of all vehicles were at this speed or slower.
Ten-Mile Pace: The range of speeds in which the majority of vehicles were traveling.
Vehicles per Hour: On busy streets, the device cannot accurately count vehicles in the far lane.

20-0605	9/4/2020	BACKING	Unit 1 arrived at 7533 Woodcutter to make a delivery. While backing the tractor/trailer southbound, Unit 1 struck a mailbox and fire hydrant near the roadside. CITE
20-0606	9/4/2020	HIT-SKIP	Unit 1 was traveling southbound in the lot at 7533 Woodcutter Dr., turned traveling westbound and struck the south gate. Unit 1 continued traveling westbound and then struck the north gate. CITE

20-0608	9/4/2020	ACDA	Units 1, 2 and 3 were eastbound on SR 750. Unit 2 and Unit 3 were stopped in traffic. Unit 1 failed to stop and struck Unit 2 causing Unit 2 to strike Unit 3. CITE
20-0620	9/10/2020	CONTROL	<i>Injury</i> Unit 1 was traveling southbound on S Liberty St., traveled southeast through the northbound lane of travel, then went off the roadside. Unit 1 continued southbound at 160 S Liberty St. striking a rock, went airborne, struck a tree then continued southbound striking another tree. CITE
20-0648	9/19/2020	ACDA	Unit 2 was stopped at the light at SR 750 and Liberty St. headed northbound on S. Liberty Rd. when Unit 1 heading the same direction, failed to stop in time and rear-ended Unit 2. CITE
20-0651	9/19/2020	ACDA	Unit 2 was stopped at the traffic light on Grace Dr. S. when it was struck in the rear by Unit 1 who accelerated too quickly when the light turned green. CITE
20-0660	9/22/2020	BACKING	Unit 1 was parked facing southbound in a handicapped parking spot at 10560 Sawmill Pkwy. Unit 2 was parked facing northbound in the same lot, behind Unit 2. Both units backed out of their spaces simultaneously, striking each other.
20-0663	9/23/2020	CONTROL	<i>Injury</i> Unit 1 was traveling eastbound on Presidential Pkwy. Unit 1 drove off the roadway to the left, through a fence, and struck a residence at 343 Whitaker Ave S. CITE
20-0671	9/27/2020	YIELD	Unit 1 was traveling westbound on Ridge Side Dr. Unit 1 pulled near the curb at 308 Ridge Side Dr. to allow a larger vehicle, that was traveling eastbound, to pass by Unit 2 was traveling west bound on Ridge Side Dr and thought Unit 1 was parked and attempted to pass. As Unit 2 passed Unit 1, Unit 1 sideswiped Unit 2 while attempting to resume traveling westbound.
