#### **CRISIS INTERVENTION TEAM**

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and assigns follow up by agencies such as Maryhaven, SourcePoint, Syntero, or the Delaware County Board of Mental Health.

#### **TRAINING**

In February, the department conducted 104 hours of total training to include Legal Updates, Lethal Use of Force and OIS Investigations, Ethics and Professionalism, Domestic Violence Legal Updates, and PELCAA training.

### TRAFFIC SURVEY (STEALTH STAT)

The Police Department uses this data to assign officers for selective enforcement efforts.

**Average Speed:** The average speed of all vehicles registered by the StealthStat device. **85th Percentile:** 85 percent of all vehicles were at this speed or slower.

**Ten-Mile Pace:** The range of speeds in which the majority of vehicles were traveling. **Vehicles per Hour:** On busy streets, the device cannot accurately count vehicles in the far lane.


## **USE OF FORCE**

# **TRAFFIC CRASHES**

CASE	DATE	CAUSE	NARRATIVE
22-02301	2/4/22	YIELD	Unit 2 was stopped at the traffic light exiting the parking lot of 3958 W. Powell Rd. Unit 1 was traveling south on Sawmill Pkwy. and turned right traveling southwest. Unit 1 struck Unit 2 while turning into the parking lot.
22-02699	2/9/22	ACDA	Units 1 and 2 were northbound at the access road near 10688 Sawmill Pkwy. Unit 2 slowed for traffic and Unit 1 failed to stop and struck Unit 2.
22-02839	2/11/22	ACDA	Unit 2 was stopped in traffic, facing west on Seldom Seen Rd. Unit 1 was stopped in traffic behind Unit 2. Unit 1 traveled west and struck Unit 2 in the rear of the vehicle.
22-03024	2/14/22	HIT-SKIP	Unit 2 was traveling northbound on Olentangy River Rd and pulled over to deliver mail near 9011 Olentangy River Rd. Unit 1 was traveling northbound on Olentangy River Rd and side swiped Unit 2. Unit 1 continued northbound on Olentangy River Rd without stopping. Unit 1 was observed to be a semi-truck, although no license plate information was observed.
22-03270	2/18/22	HIT-SKIP	Unit 2 was backed into a parking space at 47 Murphy Parkway. Unit 1 struck Unit 2 and failed to report the crash. The area was checked and no cameras were observed.
22-03511	2/22/22	HIT-SKIP	Unit 1 is unknown. It is believed that Unit 1 struck a mailbox and left the scene. Unknown damages to Unit 1.
22-03517	2/22/22	ACDA	Unit 2 and Unit 3 were stopped headed eastbound on SR 750 as a vehicle was attempting to turn northbound onto Olentangy Ridge Pl. Unit 1 was unable to stop in time and struck the back of Unit 2 which then struck the back of Unit 3. Unit 4 was able to successfully swerve and avoid striking Unit 1 by going into the ditch. CITE
22-03784	2/27/22	ACDA	Unit 2 was traveling south on N. Liberty St. when he approached the intersection of Olentangy St. He stated he stopped at a red traffic signal. Unit 1 was traveling behind Unit 2 also going south. Unit 1 stated he did not stop in time before striking Unit 2 rear ending him. Unit 1 stated he noticed some ice in the road as he was slowing down. CITE
