City Manager White gave a brief summary and overview.

City Engineer Huber gave a brief summary and overview.

Scott Seaman gave a presentation, including a proposal summary and project narrative.

Councilmember Bertone asked if GPD were to find some structural issues, how it would affect the timeline as he just wants to see this project move forward.

Scott Seaman replied this was meant as a culvert to carry water underneath as well as carry the tracks and train above. If it does that, it fulfills the need of the railroad. The City wishes to use the culvert as a pedestrian path. Should there be structural issues, it would be up to the railroad to correct those whenever they see the need as the railroad does not want to spend any money. Should the City want to pursue the pedestrian tunnel, it would be up to the City to make the structure safe for pedestrians.

Councilmember Bertone stated the railroad could basically say to the City, just close the culvert so it cannot be used, which this could be a possibility. He asked about deed restrictions.

Mr. Seaman responded there currently is a deed restriction. When the owner of the property sold it to the railroad there was a restriction and he believed the restriction expires is 2034. We need to coordinate with the railroad to get another temporary easement for construction and improvements.

Councilmember Counts said the culvert was intended for water since 1990 when it was built. The City converted it for pedestrian use. He said if the tunnel was not there, he feels there would be a problem because the only access to the other side of town is at-grade crossings. If the goal of Council is to have a safe crossing to the other side of town, this is probably it.

Councilmember Drummond spoke about the stormwater maintenance and asked if this had to be dealt with initially prior to construction of the pedestrian tunnel.

Mr. Seaman said nothing will change without improvements, so we have to figure out the best way to mitigate it, giving the City options and go from there.

Mayor Swartwout opened the floor for public comment. Seeing none, Mayor Swartwout closed the public comment portion for Resolution 2022-21.

Councilmember Lorenz asked if Council were to adopt this Resolution as is, is it also adopting the additional services.

Law Director Ashrawi replied no, the Resolution authorizes the City Manager to enter into a professional services agreement with GPD for the scope of services as outlined in the proposal. Regarding the additional services, they would only apply, if authorized in the future.

Councilmember Counts advised there is a transfer and authorization in the Capital Improvement Fund for \$106,000.00.
