**A RESOLUTION TO RESCIND RESOLUTION 2022-26.**

**WHEREAS,** City Council adopted Resolution 2022-26, which renamed one of the City's funds from "Voted Capital Improvements Fund" to "Capital Improvements Fund;" and

**WHEREAS,** After the adoption of Resolution 2022-26, the City discovered an existing fund – Fund 491 – which was already titled "Capital Improvements Fund;" and


**WHEREAS,** to avoid any confusion, the City wishes to rescind Resolution 2022-26 and to reinstate the name "Voted Capital Improvements Fund" for Fund 494.

**NOW THEREFORE BE IT RESOLVED BY THE CITY OF POWELL, COUNTY OF DELAWARE, STATE OF OHIO, AS FOLLOWS:**

Section 1: That the Council of the City of Powell hereby rescinds Resolution 2022-26 and reinstates the name "Voted Capital Improvements Fund" for Fund 494.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of Council and any of the decision making bodies of the City of Powell which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the City of Powell, Delaware County, Ohio.

Section 3: This Resolution shall be in full force and effect immediately upon adoption.



RESOLUTION 2022-26

A RESOLUTION TO RENAME THE VOTED CAPITAL IMPROVEMENTS FUND.

WHEREAS, Ordinance 2002-34, adopted by City Council on August 6, 2002, established a capital project fund known as the Parks and Recreation Capital Projects Construction Fund; and

WHEREAS, Resolution 2012-21, adopted by Council on November 20, 2012, renamed the fund the "Voted Capital Improvements Fund."

WHEREAS, to allow for continuity and simplicity, the finance director wishes to rename this fund to the "Capital Improvements Fund."

WHEREAS, the aforementioned fund will receive funding as established by the Capital Improvements Program funding policy.

NOW THEREFORE BE IT RESOLVED BY THE CITY OF POWELL, COUNTY OF DELAWARE, STATE OF OHIO AS FOLLOWS:

RESCINDED

Section 1: That the Council of the City of Powell hereby renames the Voted Capital Improvements Fund to the "Capital Improvements Fund."
