City Manager White stated at previous Finance Committee meetings, the policy of the allocation of the new income tax resources was discussed. In order to accommodate the internal fund transfer there was a need to create a standalone fund which was done at the previous Council meeting. Upon further review of the actual fund, the Finance Director uncovered a fund more closely related and felt it was most appropriate to rescind the previous legislation and go forward with the fund accounting so the chart of the accounts are maintained.

Finance Director Ocheltree clarified the original resolution didn't create a new fund, it was renamed the Voted Capital Improvement Fund. There was a Capital Project Fund already in place and having two funds with similar names with the same purpose, is not desired.

Mayor Swartwout stated this was essentially a procedural measure for clarification as opposed to anything substantive.

City Manager White affirmed.

Mayor Swartwout opened the floor for public comment. Seeing none, Mayor Swartwout closed the public comment portion for Resolution 2022-28.

Finance Director Ocheltree stated the first appropriation is for the General Fund, Finance, Operating, Banking Fees, in the amount of \$5,500. The second appropriation is for the General Fund, Finance, Operating, Income Tax Collections, in the amount of \$185,500. The third appropriation is for the Parks and Recreation Programs Fund, Special Events, in the amount of \$50,000.

Councilmember Lorenz stated for the amount of money the City is paying for RITA to be the income tax collector, a staff member could do this, and wondered when this would be looked into to bring that in house.

Finance Director Ocheltree advised the Finance Department would be more than happy to do an analysis to see what it will take. She also advised in her experience, she believed it would take approximately three staff members.

Councilmember Lorenz stated he believed it could be done with one.

Councilmember Bennehoof spoke about cross checking in referencing the federal government and state local tax alignments, would not be available without RITA.

City Manager White advised it is the number of tax filers that are represented by RITA that are in excess of one million, which provides the City ability to cross reference local tax forms with federal IRS forms. With approximately just under 15,000 filers, we would lose that capability because we do not qualify as a statutory entity due to our small size. He also advised the contract itself is a percentage of revenues collected.

Mayor Swartwout opened the floor for public comment. Seeing none, Mayor Swartwout closed the public comment portion for Ordinance 2022-15.

Community Diversity and Advisory Committee – Heather Karr advised the committee would be meeting on July 20, 2022, at 6:00 p.m. to finalize the details on Passport to Powell.

Planning & Zoning Commission – Claudia Husak stated the commission's next meeting would be July 13, 2022, at 6:30 p.m.

Powell CIC – Brian Lorenz advised the next meeting is scheduled for next Tuesday at 7:00 p.m. to discuss the economic development plan and the consultant search to help facilitate some of those needs.
