NOTABLE CASES








K9 ACTIVITY

TRAINING

In September the department conducted 534.25 hours of training. Continuing Professional Training (CPT) included BCI Lethal Use of Force and OIS Investigations, Use of Deadly Force and Legal Guidelines Critical Thinking in Use of Force Situations, Objective Reasonableness, and Qualified Immunity. Other agency training included Confident Non-



Escalation, NIMS IS-200 and IS-800, Shotgun and AR15 Armorer, Midwest Crisis Negotiator Conference, Triage, Patrol Related Canine Evaluation, Special Purpose Canine Unit Evaluation, Public Records 101 and 102, Core Criminal Investigation, Firearms/Defensive Tactics, and Street Sergeant: Evidence Based First Line Supervision.

USE OF FORCE

The Powell Police Department carefully tracks all uses of force by the agency. There were no uses of force in September. •

DRONES

The drones were not deployed in September. •

CRISIS INTERVENTION TEAM

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and assigns follow up by agencies such as Maryhaven, SourcePoint, Syntero, or the Delaware County Board of Mental Health.

In September, there were three CIT calls.

COMMUNITY ORIENTED POLICING

TRAFFIC SURVEY (STEALTH STAT)

The Police Department uses this data to assign officers for selective enforcement efforts.

Average Speed: The average speed of all vehicles registered by the StealthStat device.
85th Percentile: 85 percent of all vehicles were at this speed or slower.
Ten-Mile Pace: The range of speeds in which the majority of vehicles were traveling.
Vehicles per Hour: On busy streets, the device cannot accurately count vehicles in the far lane.

22-16110	9/2/2022	FAILURE TO YIELD	<i>Injury</i> Unit 1 was northbound on Sawmill Pkwy traveling on the right side of the road, approaching the intersection of Rutherford Rd. Unit 1 had a red light, but proceeded through the intersection. Unit 2 was westbound on Rutherford Rd. and proceeded through the intersection of Sawmill Pkwy. on a green light. Unit 2 struck Unit 1 as he proceeded through this intersection.
22-16164	9/2/2022	BACKING	Unit 1 was backing out of a parking space at Giant Eagle when she noticed Unit 2 backing out of a space at the same time. Unit 1 reportedly stopped her vehicle to allow Unit 2 to back out of their space. Unit 2 continued to back out of their parking spot striking Unit 1.
22-16247	9/4/2022	FAILURE TO YIELD	Unit 1 failed to yield before entering Sawmill Pkwy and struck Unit 2 traveling northbound. CITE
22-16257	9/4/2022	FAILURE TO CONTROL	Unit 1 was passing Unit 2 which was parked when Unit 1 drove too close to Unit 2 striking its side mirror.
22-16584	9/9/2022	FAILURE TO CONTROL	Unit 2 was parked facing east in a parking lot on Depot St. Unit 1 was traveling south on Depot St. and stopped

			at the stop sign. Unit 1 turned left traveling southeast to Scioto St. and struck Unit 2. CITE
22-16837	9/12/2022	ACDA	Unit 2 was stopped in traffic traveling north on Liberty St. Unit 1 was traveling north on Liberty St. and struck Unit 2 in the rear of the vehicle. CITE
22-16865	9/13/2022	DEER	Unit 1 was eastbound on Home Rd. when they struck a deer.
22-16880	9/13/2022	FAILURE TO CONTROL	Unit 1 was eastbound on Presidential Pkwy. Unit 2 was parked on Presidential Pkwy. The driver of Unit 1 was attempting to pass the parked vehicle and attached tool trailer. The driver of Unit 1 was blinded by the sun, but still thought she had enough room to pass safely. Unit 1 struck the rear of the tool trailer.
22-16889	9/13/2022	FAILURE TO CONTROL	Unit 1 was southbound on Advocet Dr. as he attempted to pass two parked vehicles. There were two additional dump trucks on the opposite side of the roadway parked in a no parking zone. Unit 1 struck the mirror of Unit 2, causing damage to the vehicle. Unit 2 was legally parked and unoccupied at the time of the accident.
22-16892	9/13/2022	FAILURE TO YIELD	Unit 2 was southbound on S. Liberty St. Unit 1 was turning southbound from a stop sign and failed to see Unit 2. Unit 1 struck Unit 2 while turning southbound onto S. Liberty St. CITE
22-17000	9/15/2022	BACKING	Unit 1 and 2 were backing from stalls in the lot of 4000 W. Powell Rd. The two units struck each other while backing. It is undetermined which unit is at fault.
22-17070	9/16/2022	FAILURE TO YIELD	Unit 2 was southbound on Sawmill Pkwy. at Village Club Dr. Unit 1 was northbound on Sawmill Pkwy. in the left turn lane at Village Club Dr. Unit 1 started to make a left turn and struck Unit 2 in the side. Unit 2 then drove off the right side of the road striking a curb before continuing down the road 229 feet and striking a curb and a guardrail. CITE
22-17327	9/20/2022	FAILURE TO CONTROL	Unit 1 was traveling westbound on Delaney's Cir when it went around Unit 2, which was parked, and the back bumper struck the front bumper of Unit 2. CITE
22-17420	9/22/2022	FAILURE TO YIELD	<i>Injury</i> Unit 2 was southbound on Thornbury Ln. Unit 1 was eastbound on the bicycle path/sidewalk near Thornbury Ln. Unit 2 stopped at the stop sign on Thornbury Ln. and started forward. Unit 2 stopped at the bike trail stop sign and then preceded forward into the path of Unit 2. Unit 2 struck Unit 1.

22-17453	9/22/2022	DEER	Unit 1 was westbound on SR 750. Unit 1 struck a southbound deer that entered the roadway.
22-17456	9/22/2022	ACDA	Units 1 and 2 were eastbound on SR 750. Unit 2 stopped for traffic. Unit 1 failed to stop and struck Unit 2. CITE
22-17891	9/30/2022	CONTROL	Unit 1 was attempting to park at CVS. Unit 1 accelerated instead of stopping and struck a support pole for the building.
