NOTABLE CASES



The new system measures all non-zero response times on every type of call. This is a more accurate measurement. At the same time, we are experiencing high absences from illness and surgeries. With fewer officers on patrol, response times tend to increase.

CRISIS INTERVENTION TEAM

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and

TRAINING

In January the department conducted 53.5 hours of training to include Legal Updates, Core Criminal Investigations, and Child Exploitation/Trafficking training. ◆

USE OF FORCE

The Powell Police Department carefully tracks all uses of force by the agency. There was one use of force in January:

Officers responded to a report of an unruly juvenile who would not visit a doctor as requested or give up her phone to her grandmother. She was briefly placed in handcuffs to retrieve the phone. Due to her behavior and her refusal to return home with her grandmother, she was taken to a hospital on a mental health admission. The juvenile struck an officer and was comabtive with the medics transporting her.

TRAFFIC SURVEY (STEALTH STAT)

The Police Department uses this data to assign officers for selective enforcement efforts.

Average Speed: The average speed of all vehicles registered by the StealthStat device. **85th Percentile:** 85 percent of all vehicles were at this speed or slower.

Ten-Mile Pace: The range of speeds in which the majority of vehicles were traveling. **Vehicles per Hour:** On busy streets, the device cannot accurately count vehicles in the far lane.



22-00038	1/1/2022	BACKING	Unit 1 was parked west of Unit 2 in a parking spot off Sawmill Parkway. Unit 2 opened the rear driver side door. Unit 1 traveled north striking Unit 2 in the rear driver side door.
22-00131	1/3/2022	FAILURE TO CONTROL	Unit 1 was Northbound on Sawmill Parkway at Seldom Seen. Unit 1 increased speed to make it through the light. Unit 1 lost control crossed into the Southbound lanes and came to rest on the West curb in the Southbound lane. CITE
22-00421	1/7/2022	HIT-SKIP	Unit 2 was traveling west on Home Rd. near Sawmill Pkwy. Unit 1 was traveling east on Home Rd. and turned left traveling northeast, striking Unit 2.
22-00528	1/9/2022	HIT-SKIP	Unit 2 was parked in the Giant Eagle parking lot. Unit 1 struck Unit 2 in an unknown fashion and left the area.

Unit 1 is unknown.
22-01493	1/23/2022	HIT-SKIP	Unit 2 was traveling northbound on SR 315. Unit 2 attempted to make a left turn onto Retreat Ln. and was rear ended by Unit 1. Unit 1 fled the scene traveling northbound on SR 315. A description of Unit 1 was not observed.
22-01537	1/24/2022	FAILURE TO CONTROL	Unit 1 was traveling northwest on Sawmill Pkwy. north of Trail Lake Dr. Unit 1 ran off the road to the right into snow, struck the curb, and then the guardrail. Unit 1 then spun, ran off the road to the left, and struck the curb. Unit 1 spun again, ran off the road to the right, and struck the curb.
