NOTABLE CASES

Assault | While officers were trying to find an adult to take responsibility for an intoxicated person, that person became agitated and struck a police officer. He was charged with disorderly conduct, assault, and assault on a law enforcement officer.

Theft | Police were called after a suspect was spotted pulling in front of multiple residences, jumping out of her vehicle and taking delivered packages off of porches. Someone photographed the suspect's car and posted it on Facebook where it was recognized. Police spoke to the suspect who advised she did it because she was bored. The property, which included 27 bags of Lifesaver candy, was returned to the owners, and the suspect was charged with theft. ◆



TRAINING

In December the department conducted 92.75 hours of training including All Hazards Plan, Delaware County Common Pleas Specialized Dockets, Performance Evaluations for Law Enforcement, Alco-Sensor PBT, Sexual Offenses: Mind and Motivation, 10 Myths of Sexual Assault, Ohio Ethics Law 2022, and a number of OPOTA Online courses. ◆

USE OF FORCE

The Powell Police Department carefully tracks all uses of force by the agency. There were two uses of force in December.

- Officers were called to the scene of a mental health crisis where an individual was actively attempting to harm herself. An officer restrained her arms behind her back using joint manipulation and was able to handcuff her. The subject kicked and spat at officers and slipped out of the bed restraints in the medic. She stopped resisting once she arrived at Children's Hospital.
- ❖ An Uber driver called officers to help with an intoxicated passenger who was refusing to get out of the vehicle. Officers called the subject's father to come and take responsibility for him. That caused the subject to become agitated and strike the police sergeant. Police used balance displacement and a knee to the common peroneal nerve to take the subject to the ground and handcuff him. He was charged with disorderly conduct, assault, and assault on a law enforcement officer. ◆

DRONES

CRISIS INTERVENTION TEAM

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and assigns follow up by agencies such as Maryhaven, SourcePoint, Syntero, or the Delaware County Board of Mental Health.

In December, there were two CIT calls. •

TRAFFIC SURVEY (STEALTH STAT)

The Police Department uses this data to assign officers for selective enforcement efforts.

Average Speed: The average speed of all vehicles registered by the StealthStat device. **85th Percentile:** 85 percent of all vehicles were at this speed or slower.

Ten-Mile Pace: The range of speeds in which the majority of vehicles were traveling. **Vehicles per Hour:** On busy streets, the device cannot accurately count vehicles in the far lane.

22-21796	12/1/2022	YIELD	While exiting the parking lot near 3958 W. Powell Rd headed east, Unit 2 was struck in the right side by Unit 1. Unit 1 was turning right from the south to the east and did not see Unit 2 and struck Unit 2.
22-22079	12/5/2022	CONTROL	Unit 1 is unknown. Unit 1 appeared to have run off the road, driving over a curb and striking a stop sign near Middlebury Way and Bovee Ln.
22-22129	12/6/2022	YIELD	Injury Unit 2 was northbound on Sawmill Pkwy. in the area of N. Hampton Dr. Unit 2 was southbound on Sawmill Pkwy. and attempted to make a left turn onto N. Hampton Dr. Unit 1 pulled into the path of Unit 2. Unit 2 struck Unit 1 and continued off the right side of

			the roadway after separation. After separation, Unit 1 traveled northbound on Sawmill Pkwy., returning to the southbound lanes, striking a curb before coming to rest in the grass west of Sawmill Pkwy. CITE
22-22182	12/7/2022	BACKING	Unit 2 was parked on Wallsend Ct. Unit 1 backed from the driveway of 142 Wallsend Ct. and struck Unit 2.
22-22191	12/7/2022	BACKING	Unit 2 was parked at a business on W. Powell Rd. Unit 2 was struck by Unit 1.
22-22368	12/10/2022	BACKING	Unit 2 was backing from the north to the south. While fully backed and attempting to drive towards the east, Unit 2 was struck in the right rear by Unit 1, who began to back from the south to the north.
22-22522	12/12/2022	CONTROL	Unit 1 was southbound on N. Liberty St at Adventure Park Dr. Unit 1 drove off the right side of the roadway, struck a street sign and a mailbox.
22-22614	12/13/2022	CONTROL	While parked facing south, Unit 1 said the brakes didn't work properly while starting. Unit 1 went over the curb south, crossed the mail drop off lane, and then struck a fence south of the drop off lane damaging the fence.
22-23061	12/20/2022	BACKING	Injury Unit 2 was parked in the lot of 285 S. Liberty. Unit 1 was backing from a parking stall after turning around. Unit 1 backed into Unit 2.
22-23072	12/20/2022	HIT-SKIP	Unit 2 was a parked motor vehicle. Unit 2 was struck by an unknown vehicle in the parking lot of The Primrose School.
22-23073	12/20/2022	MARKED LANES	Units 1 and 2 were northbound on Sawmill Pkwy, south of Presidential Pkwy. The involved units came into contact with each other on the roadway. The occupants of Unit 2 reported that the driver of Unit 1 changed lanes into their vehicle. The operator of Unit 1 advised that Unit 2 changed lanes into his vehicle. Based on the fact that there are no independent witnesses for this crash, fault cannot be determined at this time.
22-23559	12/29/2022	BACKING	Unit 1 was backing up in the parking lot of Adventure Park. Unit 1 became distracted by the passengers in the vehicle and struck Unit 2 which was a parked vehicle.
22-23599	12/28/2022	CONTROL	Unit 1, an unknown white Honda Civic traveling northbound on Winding Woods Drive, struck the mail box. Unit 1 left the scene leaving a portion of the right

			front bumper and parts belonging to a lower right fog lamp.
22-23617	12/29/2022	YIELD	Unit 2 was southbound on Hopewell at Ridgeside Dr. After stopping for the stop sign, Unit 2 proceeded through the intersection. Unit 1 was eastbound on Ridgeside Dr., failed to stop at the stop sign prior to turning left at the intersection and struck Unit 2. CITE
22-23650	12/30/2022	BACKING	Unit 1 and 2 were waiting for a gate to raise at a business on Sawmill Pkwy. Unit 1 backed up to attempt to trip the sensor and backed into Unit 2. Unit 1 then proceeded through the carwash and left the scene.
22-23663	12/30/2022	CONTROL	Unit 1 and unit 2 were northbound of Sawmill Parkway in heavy traffic. Unit 1 attempted to change lanes and struck Unit 2 on the front right. CITE
