

#### **NOTABLE CASES**

Vandalism | A large construction site on Moreland Drive was entered and vandalized. Suspects discharged fire extinguishers and used them to gain entry into two apartments, then threw the extinguishers into the pool. They splattered a bucket of white paint onto the concrete and damaged the pool fencing. Detectives processed the scene and took video from nearby locations.

**Forgery** | A local bank declined to cash a check that appeared to have been washed and forged. The investigation is ongoing. ◆



#### **COMMUNITY ORIENTED POLICING**

- Officer Audrey Wilt held Coffee and Conversations with the Parks and Recreation Department and the Delaware County District Library.
- With Sergeant Scott Roach, Officer Brandon Phenix, Audrey held Women's Self Defense classes over two Saturdays. Supported by the PCPAAA.
- Officer Wilt helped teach a Personal Safety class at Source Point.



- ❖ Powell Citizens Police Academy Alumni Association held their first meeting of the year. Jackie Bain from the Delaware County Health District talked to the group about CarFit for seniors. Attendance was excellent.
- Officer Wilt performed six car seat installations.

#### **CRISIS INTERVENTION TEAM**

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and assigns follow up by agencies such as Maryhaven, SourcePoint, Syntero, or the Delaware County Board of Mental Health.

In January, there were two CIT calls. •

#### TRAFFIC SURVEY (STEALTH STAT)

The Police Department uses this data to assign officers for selective enforcement efforts.

**Average Speed:** The average speed of all vehicles registered by the StealthStat device. **85th Percentile:** 85 percent of all vehicles were at this speed or slower.

**Ten-Mile Pace:** The range of speeds in which the majority of vehicles were traveling. **Vehicles per Hour:** On busy streets, the device cannot accurately count vehicles in the far lane.



23-00167	1/3/2023	ACDA	Units 1 and 2 were westbound on SR 750 near Grace Dr. Unit 2 stopped for a traffic signal. Unit 1 failed to stop and struck Unit 2. CITE
23-00170	1/3/2023	BACKING	While backing from a private construction area, Unit 1 backed onto a bike path from the south to the north and struck an illuminated crosswalk sign located at the south west corner of Seldom Seen Rd. and N. Liberty St.
23-00380	1/6/2023	FAILURE TO YIELD INJURY	Unit 1 attempted to cross Sawmill Pkwy. to turn left from Market St. Unit 1 did not see Unit 2 which was northbound on Sawmill Pkwy. in the passing lane. Unit 2 struck Unit 1. The impact caused Unit 1 to rotate. Unit 1 spun into Unit 3 which was a southbound semi-truck.

Liberty St. south of Sanderling Ave. Unit 1's driver looked over to care for her canine and drove off the right side of the road. 23-01355	1/20/2023	CONTROL	Unit 1 was traveling northwest on Murphy Pkwy. when they ran off road right and struck four trees. The uprooted trees were pushed into fencing, causing damage to the fence. CITE
23-01395	1/21/2023	ACDA	Unit 2 was stopped westbound on Olentangy St. at the Grace Dr. traffic light. Unit 1 was westbound on Olentangy St., failed to stop, and rear-ended Unit 2.
23-01608	1/24/2023	ACDA	While stopped for traffic on Sawmill Pkwy. southbound, Unit 2 was struck in the rear by Unit 1 who was slowing for stopped traffic. CITE
23-01868	1/28/2023	HIT-SKIP	Unit 1 turned left from W. Olentangy St. to N. Liberty St. Unit 1 ran off road on the right and struck a street sign, then crossed N. Liberty St., struck a curb, then knocked down a utility light pole. 23-01993	1/30/2023	FAILURE TO YIELD INJURY	Unit 1 was northbound on Sawmill Pkwy. in the westbound turn lane for Home Rd. Unit 2 was southbound on Sawmill Pkwy. Unit 1 failed to yield on a left turn and was struck by Unit 2. CITE
23-02011	1/30/2023	HIT-SKIP	Unit 2 was parked facing west in a parking lot at 7474 Guard Well St. Unit 1 was parked facing south in a parking lot. Unit 1 traveled northwest, and struck Unit 2 in the rear bumper. Unit 1 left the scene without contacting Unit 2.
23-02052	1/31/2023	FAILURE TO CONTROL	Unit 1 was eastbound on SR 750 when they lost control of their vehicle due to icy roads and went left of center, off the road and into the ditch and flipped their vehicle.
23-02081	1/31/2023	BACKING	Unit 1 and 2 were in the parking lot of 8720 Moreland St. While waiting for a pedestrian and backing vehicle facing north bound, Unit 2 was struck in the left rear end by Unit 1, who was backing towards the northeast from a parking spot.
