

#### **TRAINING**

#### **USE OF FORCE**

The Powell Police Department carefully tracks all uses of force by the agency. There was one use of force in April.

❖ Powell officers assisted the Columbus Division of Police in performing felony stops on a car and a truck with a stolen trailer. The felony stops involved officers displaying their handguns which is considered a use of force. Three suspects were arrested without incident. ◆

#### **DRONES**

#### CRISIS INTERVENTION TEAM

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and assigns follow up by agencies such as Maryhaven, SourcePoint, Syntero, or the Delaware County Board of Mental Health.

In April, there were three CIT calls.

The Police Department uses this data to assign officers for selective enforcement efforts.

**Average Speed:** The average speed of all vehicles registered by the StealthStat device.

**85th Percentile:** 85 percent of all vehicles were at this speed or slower.

**Ten-Mile Pace:** The range of speeds in which the majority of vehicles were traveling.

**Vehicles per Hour:** On busy streets, the device cannot accurately count vehicles in the far lane.

#### RETIREMENT



Officer Scott Sanford retired from the Powell Police Department on April 14, 2023, concluding a 25-year career in law enforcement. He joined the department in 1999.

"I've had the pleasure of watching Scott grow in Powell," said Chief of Police Steve Hrytzik. "It's neat to watch the people you've worked alongside reach a point in their career to retire and enjoy the next chapter."

Throughout his tenure with the Powell Police Department, Officer Sanford has been awarded Officer of the Year three times. He was also recognized with a Medal of Commendation for his heroic efforts in rescuing an individual from a burning vehicle.

In addition to his patrol duties, Officer Sanford served as the department's

accreditation manager, leading the team through a rigorous recertification process every four years. Only 10 percent of law enforcement departments are credentialed through the Commission on Accreditation for Law Enforcement Agencies (CALEA) which is recognized as the gold standard for public safety agencies and promotes best practices nationwide.

"Scott is someone you can count on to be here and do a great job," said Sergeant Scott Roach. "He's very dependable and has been a strong mentor to the younger officers on our team."

"I've known Scott for more than 25 years," said Deputy Chief of Police Ron Sallows. "We worked together in Toledo before we came to Powell as young men at the start of our law enforcement careers. It's hard to believe how quickly time passes. I know he will be missed by his co-workers and many in the community." •
