

CITY COUNCIL
MEETING MINUTES
JUNE 20, 2023

CALL TO ORDER/ROLL CALL

Mayor Daniel Swartwout called the Tuesday, June 20, 2023 meeting of City Council to order at 7:30 p.m. Councilmembers present included, Ferzan Ahmed, Jon Bennehoof, Christina Drummond, Heather Karr and Daniel Swartwout. Councilmember Tom Counts was absent. City Staff included, Andrew White, City Manager; Jeffrey Tyler, Assistant City Manager/Community Development Director; Rosa Ocheltree, Finance Director; Jason Nahvi, Human Resource Manager; Grant Crawford, Director of Public Service; Yazan Ashrawi, Law Director; and Mallory Sribanditmongkol, Strategic Communication Officer.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Councilmember Jon Bennehoof.

CITIZEN PARTICIPATION

Mayor Swartwout opened the floor Citizen Participation for comment on matters not on the evening's agenda.

Arthur Thorn, 8060 Hillingdon Drive, said he would like to know how City of Powell budget information is educated to the public and if someone could educate him on where to find the information. Also, he wanted to know how City Council works.

Rosa Ocheltree, Finance Director, said the budget is approved by City Council, posted to the website https://cityofpowell.us and distributed over social media. Budget information can be found under the Finance Department link. Ms. Ocheltree offered to walk Mr. Thorn through the budget. Further, she stated budget work sessions are open to the public and posted on the website and social media.

Andrew White, City Manager, agreed attendance at public meetings is crucial in understanding the role of City Council and said there is a very transparent process in regards to the budget. He said with respect to Mr. Thorn's position regarding the Pickle Ball Courts, Mr. White said the \$300,000 appropriated in the 2023 Capital Improvement Program (CIP) was an estimate and explained part of the allocated money was for a professional engineering firm to review the site, which found drainage issues and potential parking issues. This information has pushed cost of the project to \$657,000, which requires going before the Operations Committee with a request for additional appropriations to City Council.

Mayor Swartwout explained Citizen Participation is not a back and forth, but rather a chance for comment for items not on the agenda and offered the floor for additional comment. Hearing none, he closed this portion of the meeting.
