#### **NOTABLE CASES**

#### CRISIS INTERVENTION TEAM

Police respond to many calls that are not criminal in nature. Using a CIT (Crisis Intervention Team) disposition notifies HelpLine of Delaware and Morrow Counties that there is a need for further assistance. HelpLine reviews the call information and assigns follow up by agencies such as Maryhaven, SourcePoint, Syntero, or the Delaware County Board of Mental Health.

#### Council Goal 1-2 M4 Maintain and Publish Traffic Statistics

The Police Department uses this data to assign officers for selective enforcement efforts.

Average Speed: The average speed of all vehicles registered by the StealthStat device.

85th Percentile: 85 percent of all vehicles were at this speed or slower.

**Ten-Mile Pace:** The range of speeds in which the majority of vehicles were traveling.

Vehicles per Hour: On busy streets, the device cannot accurately count vehicles in the far lane.

23-11726	7/3/2023	FAILURE TO YIELD	Unit 1 completed an improper lane change while traveling southbound on Sawmill Pkwy near Rutherford Rd. Unit 1 cut off Unit 2 which caused Unit 2 to drive off the roadway.
23-11860	7/5/2023	ACDA	Unit 1 and Unit 2 were both stopped in the turn lane on North Hampton Dr. to turn north onto Sawmill Pkwy. Unit 1 saw the light turn green, assumed Unit 2 was also moving, and rear-ended Unit 2. CITE
23-12210	7/10/2023	ACDA	Unit 1 failed to keep assured clear distance ahead while traveling eastbound on SR 750 near Bennett Pkwy. Unit 1 rear-ended Unit 2 which caused Unit 2 to rear-end Unit 3. CITE
23-12257	7/8/2023	FAILURE TO YIELD	Unit 1 and Unit 2 were facing westbound and parked next to each other on Village Club Dr. A rear seat passenger exited Unit 2. The driver of Unit 1 did not see the open door of Unit 2 and began to pull forward. The passenger side rear wheel well flare struck the door of Unit 2.
23-12391	7/13/2023	ACDA	Unit 3 and Unit 2 were stopped in traffic near 18 N. Liberty, when Unit 1 failed to maintain assured clear distance and struck the rear of Unit 2, causing Unit 2 to strike the rear of Unit 3. CITE
23-12394	7/13/2023	ACDA	Unit 1 and Unit 2 were both southbound on Sawmill Pkwy. approaching Home Rd. intersection. Unit 2 stopped at a red light, Unit 1 failed to leave an assured clear distance ahead and struck Unit 2. CITE
23-12453	7/14/2023	BACKING	Unit 1 turned into the parking lot of 80 E. Olentangy St. and pulled into the southeast end parking spot. Unit 1 backed out of this parking spot striking Unit 2, which

			was parked right next to this space, and then left the scene.
23-12515	7/15/2023	ACDA	Units 1, 2, 3 and 4 were eastbound on SR 750 near Sycamore Ridge Dr. Units 2, 3 and 4 stopped for traffic. Unit 1 failed to stop and struck Unit 2, pushing Unit 2 into Unit 3. Unit 3 then struck Unit 4. CITE
23-12860	7/20/2023	ACDA Injury	Unit 1 and Unit 2 were both northbound on Sawmill Pkwy. stopped at the traffic light at Village Club Dr. Unit 1 was not paying attention and as the light turned green rear-ended Unit 2.
23-12874	7/20/2023	FAILURE TO YIELD	Unit 2 was southbound on Sawmill Pkwy in the west lane when Unit 1, also southbound, attempted to change lanes from the east lane prior to ensuring the lane was cleared and struck Unit 2. CITE
23-13113	7/24/2023	HIT-SKIP	Unit 2 was eastbound on SR 750 near Valley Run Dr. Unit 1 was westbound on SR 750. An unknown portion of Unit 1 entered into Unit 2's lane and struck the mirror of Unit 2. Unit 1 left the scene without reporting the crash.
23-13226	7/25/2023	ACDA Injury	Unit 1 was traveling northbound on Liberty Rd. and failed to keep an assured clear distance ahead. Unit 1 struck Unit 2 as it stopped in traffic to make a left turn onto Sanderling Ave.
23-13567	7/31/2023	ACDA	Units 1 and 2 were westbound on SR 750. Unit 2 stopped for traffic. Unit 1 failed to stop and struck Unit 2. This crash report was taken at the request of DCSO.
